NO OVERNIGHT CAMPING IN ANY KIND OF VEHICLES I.E. CARAVANS, TENTS OR ANY PERMANENT OR TEMPORARY STRUCTURE WILL BE PERMITTED BY ORDER OF THE NATIONAL DEPARTMENT OF PUBLIC WORKS. ANY PERSON FOUND TO BE IN CONTRAVENTION OF THIS NOTICE WILL BE PROSECUTED AND **MAY BE LIABLE TO A FINE OR JAIL SENTENCE.** PERMANENT STRUCTURES MUST BE REMOVED WITHIN 21 DAYS, FAILING WHICH THE DEPARTMENT WILL REMOVE THE STRUCTURES AND RECOVER COSTS OF SUCH REMOVAL FROM THE OWNERS.

NO 4X4 VEHICLES, MOTOR CYCLES OR QUAD BIKES WILL BE ALLOWED ON THE DUNESAND/OR BEACH AREA, ALL VEHICLES MUST REMAIN ON THE DESIGNATED PUBLIC ROADS. ANY VEHICLE FOUND TO BE IN CONTRAVENTION REGULATIONS REGARDING CONTROL OF USE OF VEHICLES IN A COASTAL AREA WILL BE PROSECUTED.
