

The PE Bar welcomes the following new members – Gaynor Appels, Michelle Du Toit, Ivan Lamprecht, Vuyolwethu Madokwe, Batande Ndamase, Xola Nogantshi and Morné Olivier.

Gaynor Appels completed her B. Juris and LLB at NMU (then known as UPE) in December 1996. She started her legal career in 1997as a candidate attorney at a law firm in Graaff-Reinet (V Dercksen and Partners). Gaynor was admitted as an attorney in March 1999 whereafter she practiced at V Dercksen and Partners until September 2000, when she joined the Office of the State Attorney, as an Assistant State Attorney. Gaynor was then appointed Regional Head: Legal Services for the Regional Office of the National Department of Public Works (NDPW) situated in Port Elizabeth. She was responsible for managing all litigation of the NDPW emanating from the part of the Eastern Cape that formed part of the Cape Province prior to 1994. She worked at the NDPW until she joined the Bar as a pupil member in 2017 and now holds chambers at Oasim.

Michelle du Toit is born and bred in Uitenhage and attended the Riebeek College Girls High School. After matriculating, Michelle joined the Department of Justice and Constitutional Development as an administrative clerk. Her experience while working there inspired her to enrol as a part time student at Vista University where she completed the LLB degree in 2002. After graduating, Michelle joined the National Prosecuting Authority (NPA) and prosecuted in the Eastern

Cape courts for 15 years. Michelle then took the bold decision to join the Bar and successfully completed her pupillage in 2017. Michelle holds chambers at Club Chambers.

Ivan Lambrechts went to Grey High School and matriculated in 2008. He completed his LLB at NMMU in 2012. Ivan then commenced Articles in 2013 and worked as a Professional Assistant at Brown, Braude & Vlok Inc until he commenced pupillage in 2017.
