## Ramaphosa to deliver keynote Women's Day address

Ramaphosa will deliver the keynote address at the Women's Day national commemorative event at the Khavelitsha rughy

stadium on Wednesday. The presidency said Women's Month (August) will be commemorated under the theme "Accelerating socioeconomic opportunities for empowerment of women", adding: "Every year, we observe this month to pay tribute to the more than 20,000 women who marched to the Union Buildings on August 9 1956 in protest against pass laws.

Ramaphosa will conclude the first round of the district development model presidential

imbizo in Tsomo in the Chris Hani district in the Eastern Cape on Friday. The model aims to ensure an integrated, district-based approach to service delivery.

DA leader John Steenhuisen will host a public meeting in Phoenix in Durban on Monday to discuss the implications of the Employment Equity Amendment Act. 2021 the year when Jacob Zuma was released on medical president Jacob Zuma must go back to jail after an unlawful parole decision. In July the Constitutional Court issued a ruling effectively confirming that the decision by Thobakgale's predecessor Arthur Fraser in September 2021 to grant Zuma medical parole after he had served less than two months was unlawful.

The Sunday Times reports that Thobakgale now has the task of determining what he is "empowered in law" to do: immediately grant Zuma ordinary parole, as Zuma argues he must; or send Zuma back to prison, as the DA says he must. On Tuesday, parliament's
