Department denies travel scandal claims

THE NORTHERN Cape Department of Sport, Arts and Culture has dismissed allegations that a high-ranking official allowed Expanded Public Works Programme (EPWP) interns to accompany him on regular trips to destinations including Sun City, Johannesburg and Uninston.

It is believed that the official was reprimanded, as the department is expected to fund travel, subsistence and accommodation expenses for employees. Interns, however, do not qualify for these allowances as their names do not appear on the Personnel and Salary System (Persal).

Concerns were reportedly raised as to who would be held responsible should the interns be involved in an accident or incident where they were injured or harmed.

Department spokesperson Conrad Fortune said he noted with concern the allegations being circulated.

"These allegations are baseless and appear to be aimed at tarnishing the reputation of the department," Fortune said. He said official travel was conducted strictly in line with government prescripts and approved delegations of authority.

are not permanent employees. Their travel, accommodation and subsistence expenses can only be funded in accord-ance with applicable departmental and Treasury regulations.



The Department of Sport, Arts and Culture has denied allegations that EPWP interns have been accompanying a high-ranking official on official trips.

The interns are funded under the

"The interns are funded under the EPWP budget, which is specifically allocated for skills development and work-exposure initiatives."
He explained that the participation of interns in official activities had to be approved and directly related to their learning and development objectives.

"The five EPWP staff members were selected from the group of 81 EPWP employees and allocated to the Ministry, while others were placed at various other

while others were placed at various other departmental facilities throughout the province."

"Standard procedures apply in the event of any incident involving staff or interns while on duty. The department reiterates its commitment to transparency, accountability, and adherence to all legislative and policy frameworks governing public-service conduct," Fortune stated.
