DA welcomes transfer of coastal properties from Ray Nkonyeni

The DA has welcomed the decision by Public Works and Infrastructure Minister Dean Macpherson to transfer the management of 15 state-owned properties along KwaZulu-Natal's South Coast from the ANC-1ed Ray Nkonyeni Municipality to the provincial Department of Public Works and Unfrastructure. The transfer, marked by a joint visit from Macpherson and KZN MEC for Public Works Martin Meyer yesterday, is expected to bruing relief to business owners who have long struggled under unstable leasing arrangements.

According to the DA, the move marks a turning point for the region's business and tourism sectors. "For far too long, local entrepreneurs, tourism operators and workers have suffered under unstable leasing arrangements that created adminiprocess."

leasing arrangements that created administrative uncertainty and eroded investor confidence," said DA member of the KZN Legislature Riona Gokool, who is also the



party's Ugu South constituency head.

The termination of the 2016 management agreement with the Ray Nkonyeni Municipality and the direct oversight by the provincial department, Gokool said, would "lay the foundation for transparency, accountability and sustainable growth across the coastal region".

Gokool commended both Macpherson and Meyer for what she described as "decisive and collaborative leadership that puts the public interest first,"
