Frustrated East Street Hostel residents demand action

Residents of East Street Hostel, frustrated by years of neglect of the build-ing they call home, want to meet the call home, City halfway by sharing maintenance

However, Msunduzi Municipality denies owning the Masukwana Street building, as do other relevant govern-

ment departments.
On paper, the property — now blighted by overflowing sewers and leaking water tanks on the roof — be-

longs to the provincial government. However, its departments of Trans oort, Human Settlements, and Public Works have also denied ownership of the establishment.

"We are not refusing to pay," said hostel spokesperson Smiso Mncwabe, who has lived there for six years. "We want to pay so that the government meets us halfway by maintaining the hostel. They should make arrangements on how we can pay and when they will start main-

taining the area.
"We want this place to be maintained so that it regains its former glory and is respected as it used to be. We need security and cleaners," he added.
Chairperson Zenzeleni Bhengu

who has lived there for 30 years, said the hostel was once well maintained and even had security guards. "There used to be an office inside

the hostel premises where we made our payments, but it was closed around 2006. Now, vagrants do as they please here. Staying in this place s no longer the same."

He added that no government de-

partment wants to admit ownership. with the Department of Human Set-tlements telling residents that the hostel belongs to Msunduzi Municipality, while the municipality claims otherwise. Bhengu sees this as "an accident waiting to happen".

"It also poses health risks. All we want is for the hostel to be main-tained," he said.

Msunduzi Municipality spokesper son Ntobeko Mkhize said ownership and management of the hostel fall under the jurisdiction of the KwaZulu-Natal Department of Human Settlements.

"There has never been a Msunduzi Municipality office at the hostel. Any

office previously located there was likely operated by the KZN Department of Human Settlements.
"Msunduzi Municipality's Waste Management Unit provides regular waste collection services across the content of the included the set of the services across the services a city, including the hostel. However, challenges persist, such as improper

disposal practices. Residents and users of the facility often fail to adhere to the scheduled waste collection

dates, leaving waste uncollected." She added, "Incidents of ill dumping near and around the hostel further exacerbate waste management issues."

Department of Transport and Human Settlements spokesperson Ndabezinhle Sibiya said the hostel belongs to the Department of Public

However, Department of Public Works spokesperson Steve Bhengu said the hostel is listed in the Pro-vincial Immovable Asset Register, inherited from the then Administrator Natal, and is currently vested in the name of the provincial government of KwaZulu-Natal.

"For the longest time, [the hostel] has been managed and administered by the Department of Human Settle-ments. There were previous engagements regarding the responsibility for the management of this facility, with the main challenge being the payment of municipal services and

its effective and optimal use," he said. Bhengu added that the Depart-ment of Human Settlements had citment of Human Settlements nad cit-ed challenges in paying for municipal services. "During the engagements, the Department of Human Settle-ments indicated that the Department of Public Works would have to dispose of this facility to Msunduzi

Municipality.
"It was then resolved that the de partment, as the custodian, would initiate the disposal of the [hostel]. However, when it comes to the payment of municipal services, the Department of Human Settlements, as the user department, has the responsibility to pay for such services.

"The disposal of this facility to Msunduzi Municipality has already been initiated through our disposal section. The municipality has formally advised that the matter is currently awaiting a council resolution to acquire this property by way of donation from the provincial government," he added.
