In compliance with the Public Finance Management Act, 1999 (Act 1 of 1999) and the Preferential Procurement Policy Framework Act (Act 5 of 2000), the Department of Public Works has developed a supplier register that will be used in its acquisition process.

Enterprises owned by historically disadvantaged individuals, women and disabled persons, as well as SMME's, are encouraged to apply. Suppliers will be selected from the register on the basis of the principles of DPW's Supply Chain Management policy.

Registration on the Supplier Register does not guarantee business opportunities.

Requirements: Submission of completed registration forms and relevant documents.

Registration/evaluation criteria: As stipulated in the PA-23 Application for Registration Form.
