4.1 PRICE STRUCTURE:

5. QUANTITY, ORDERS AND DELIVERY:

5.1 **QUANTITY AND ORDERS**

- a. The Quantity **(23)** reflected in the bid documents are estimated volumes for the basis of determining a bid price and as such cannot be guaranteed.
- b. The National Department of Public Works is under no obligation to purchase any stock, which is in excess of the indicated quantities.
- c. Suppliers must under no circumstances deviate from orders issued by the department.
- d. National Department of Public Works reserves the right to purchase its requirements outside of the contract:
 - If the contractor fails to perform
 - If the item (s) are urgently required and not immediately available
 - If minimum order quantity specified by the contractor exceeds an institution's Requirements
 - If an emergency arises
- e. National Department of Public Works reserves the right to cancel orders where the lead time exceeds the delivery lead time as in the final contract.

5.2 DELIVERY COMPLIANCE

- a. Bidders must comply with the delivery lead time (time from placement of order to Delivery) as quoted in bid documents. This may not be longer than 4 calendar days
