

As we step into the final quarter of the year, it is clear that our collective hard work and determination are yielding real results. Across the Department and its entities, there is a renewed sense of accountability, delivery, and momentum - all driving us towards our goal of turning South Africa into a construction site and using public assets for public good. This past month has been particularly busy and productive, with important progress made in strengthening governance, improving delivery, and building partnerships across the sector.

We began September by taking firm action to enforce accountability in the construction industry. The Construction Industry Development Board has now blacklisted forty contractors since I took office, compared to only one in the past two decades. This decisive step sends a clear message that non-performance will no longer be tolerated. Every rand spent must deliver quality infrastructure that supports economic growth and job creation. It is this kind of accountability that will rebuild public confidence and strengthen our Department's role as a capable, professional delivery unit.

At the same time, I welcomed the Cabinet's concurrence of the appointment of Ms Lorraine Naidoo as Deputy Director-General for Supply Chain Management. Her extensive experience in procurement, governance and compliance will help stabilise this crucial branch, root out corruption, and ensure that public assets are managed with integrity and professionalism. These leadership appointments are critical as we continue to reform our systems to ensure that every project, big or small, contributes meaningfully to South Africa's development.

At the start of September, I had the opportunity to address the Master Builders South Africa Annual Congress in Sun City, where I reflected on the progress we have made in rebuilding the construction sector and accelerating delivery. I also highlighted the strides made through Infrastructure South Africa (ISA) in strengthening project preparation and driving job creation. At the gathering, I was honoured to receive a recognition award on behalf of the Department – a testament to the difference industry stakeholders are already seeing in our work. This recognition belongs to all of you – the officials across the Department and its entities who are driving change with commitment and pride.

This month, ISA launched Bid Window II for project preparation support and signed a landmark agreement with the African Export–Import Bank in Algeria to establish a USD 5 million (R87 million) Joint Project Preparation Facility. I congratulate Acting Head, Mameetse Masemola, and her team for these bold steps, which will ensure that South Africa's infrastructure pipeline remains strong, bankable, and ready for investment. Through these efforts, we are ensuring that infrastructure projects move beyond planning and into construction, creating jobs and driving growth.







Later in September, in Hout Bay in Cape Town, I joined the local community to officially open the new City Sightseeing South Africa stop at Hout Bay Harbour – a project that became possible through collaboration with our property tenants in the area. This initiative will boost tourism, attract visitors to local businesses, and create jobs for the community. It is a simple but powerful example of how public assets can be used for public good, turning stateowned properties into drivers of local economic activity and community upliftment.

I was joined by Cape Town Mayor Geordin Hill-Lewis, MMC Carl Pophaim and MMC Grant Twigg in Mitchells Plain for the latest leg of our EPWP Listening Tour, where it was encouraging to see how the City of Cape Town has embraced fairness, transparency, and dignity in the management of its programme – with SMS-based recruitment notifications, skills-based placements, and a clear commitment to community impact. We will take these lessons forward as we work to reform the national programme so that it better serves communities such as Tafelsig, and continues to provide real opportunities to those who need them most.

It has already created hundreds of jobs and represents the kind of innovation and urgency that we must replicate across our infrastructure landscape.
