Bidders must comply with Pre-Qualification criteria for Preferential procurement to an EME/QSE which is at least 51% owned by black people for subcontracting. Compliance with local production and content by completing and signing PA-36 and Annexure C. Tenderers should be registered on National Treasury Central Supplier Database (CSD) and all intended subcontractors. Only contractors who are CIDB Grade 8 CE or higher are eligible to submit proposals. Failure to comply with the above listed requirements will lead to disqualification. Only B-BBEE certificate issued by SANAS accredited service providers or sworn affidavit obtainable from the Department of Trade and Industry (DTI) will be accepted.
