## CONDITIONS OF TENDER 1. LOCAL CONTENT

In terms of the stipulated minimum threshold for Local Production and Content (CEMENT 100%, CABLES 100% and DOORS 100%). Tenderers that do not meet the criteria stipulated above and in the tender document will be disqualified from further evaluation.

Only locally produced goods or services with a stipulated minimum threshold for local production and content of 100 % (Designated sector: CEMENT, CABLES AND DOORS) will be considered. Exchange rate to be used for the calculation of local content (local content and local production are used interchangeably) must be the exchange rate published by the SARB at 12:00 on the date, one week (7 calendar days) prior to the closing date of the bid. If the raw material or input to be used for a specific item is not available locally, bidders should obtain written authorization from the DTI should there be a need to import such raw material or input; and a copy of the authorization letter from DTI must be submitted together with the bid/quotation document at the closing date and time. The Department of Public Works SCM policy applies.
