<p><b>Present Condition of Antique chairs:</b></p> <p>The furniture pieces are made up of wooden frames covered in leather for the backrest; this leather is embossed and secured to the frames with elaborate pins with diamond heads; due to extended use the leather has cracked and scuffed seriously and is very dry causing red-rot to set into the leather causing it to crack and becoming scuffed during use; the back of the backrests of the 4 chairs and the bench have been covered with mock-leather which has separated from the frame in some cases and tearing of the mock leather in two case; shrinkage of the leather has occurred on the leather attached to the edges of the backrests with missing areas in some cases; the seats are covered with plastic covered cloth; oxidation of the pin studs is present.</p> <p><b>Proposed Treatment:</b></p> <p>As a first step, to dry clean the existing leather on the chairs and bench with suction assisted micro-fibre cloths and soft brushes; to remove the studs progressively and separate the leather as well as the mock-leather from the backrests of the chairs and bench; to soften the leather with a balsam; to consolidate the leather pieces with Hydroxypropyl cellulose mixed with 2% ethanol to reconstitute the leather; to fill in missing and shrunk areas with leather filings to fill in all gaps that are currently present; to apply an appropriate leather dressing to feed the leather and combat red-rot; to clean the metal stud heads with an appropriate metal cleaner; to reposition the leather backs onto their positions on the backrests of the chairs and bench; to repair the mock leather by bring together the torn areas and then position it before the leather is attached and fasten onto the backrest of the chair frames; to then lay the conserved leather and attach to the edges of the frames of the chairs and bench; to apply an appropriate leather dressing to the leather to feed the</p>
