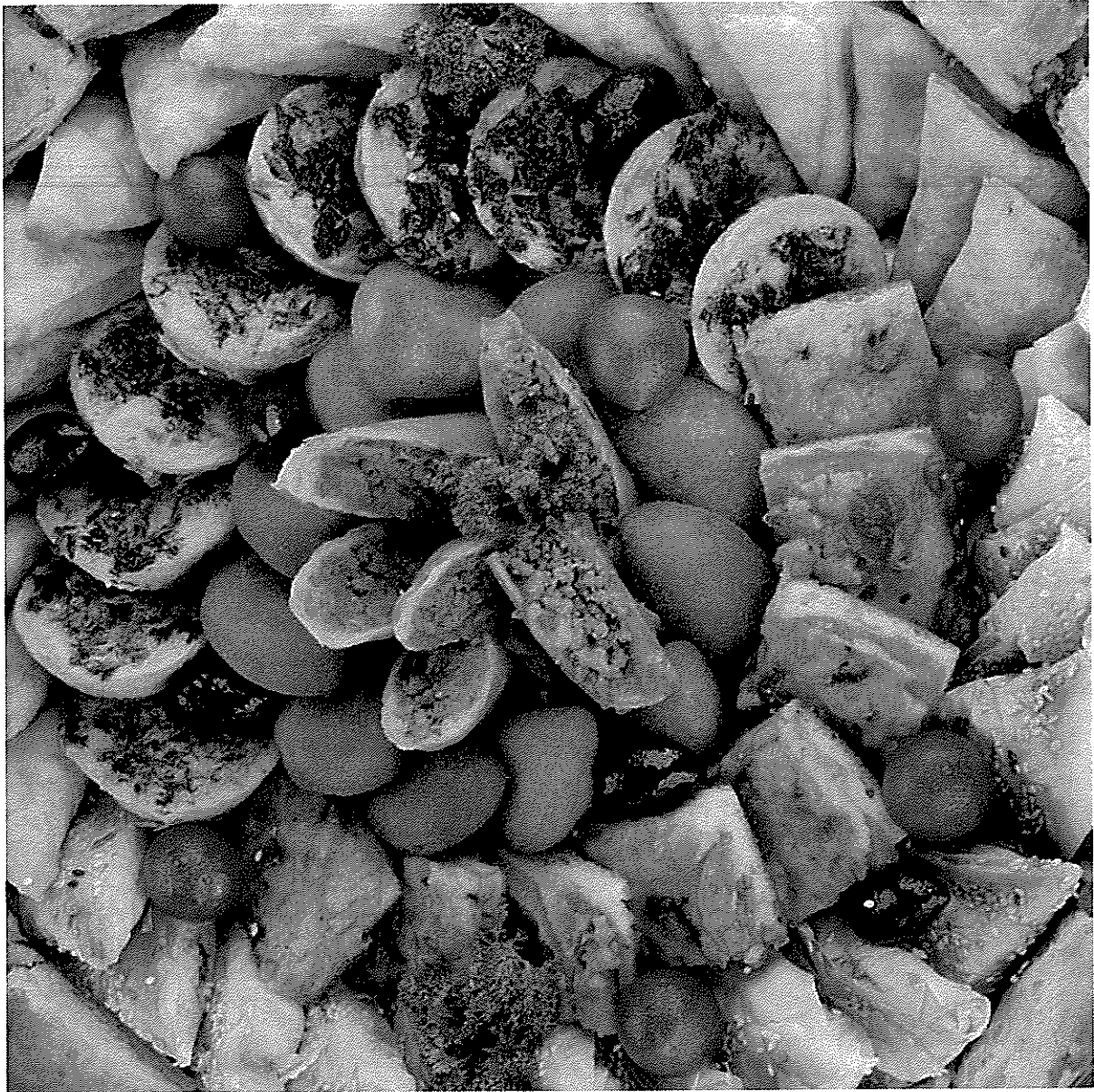
Example of meat platter



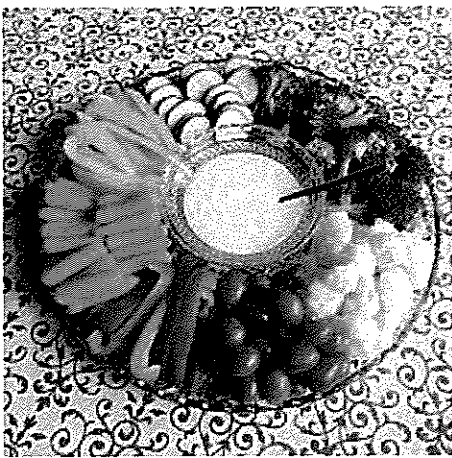
Example of fish platter



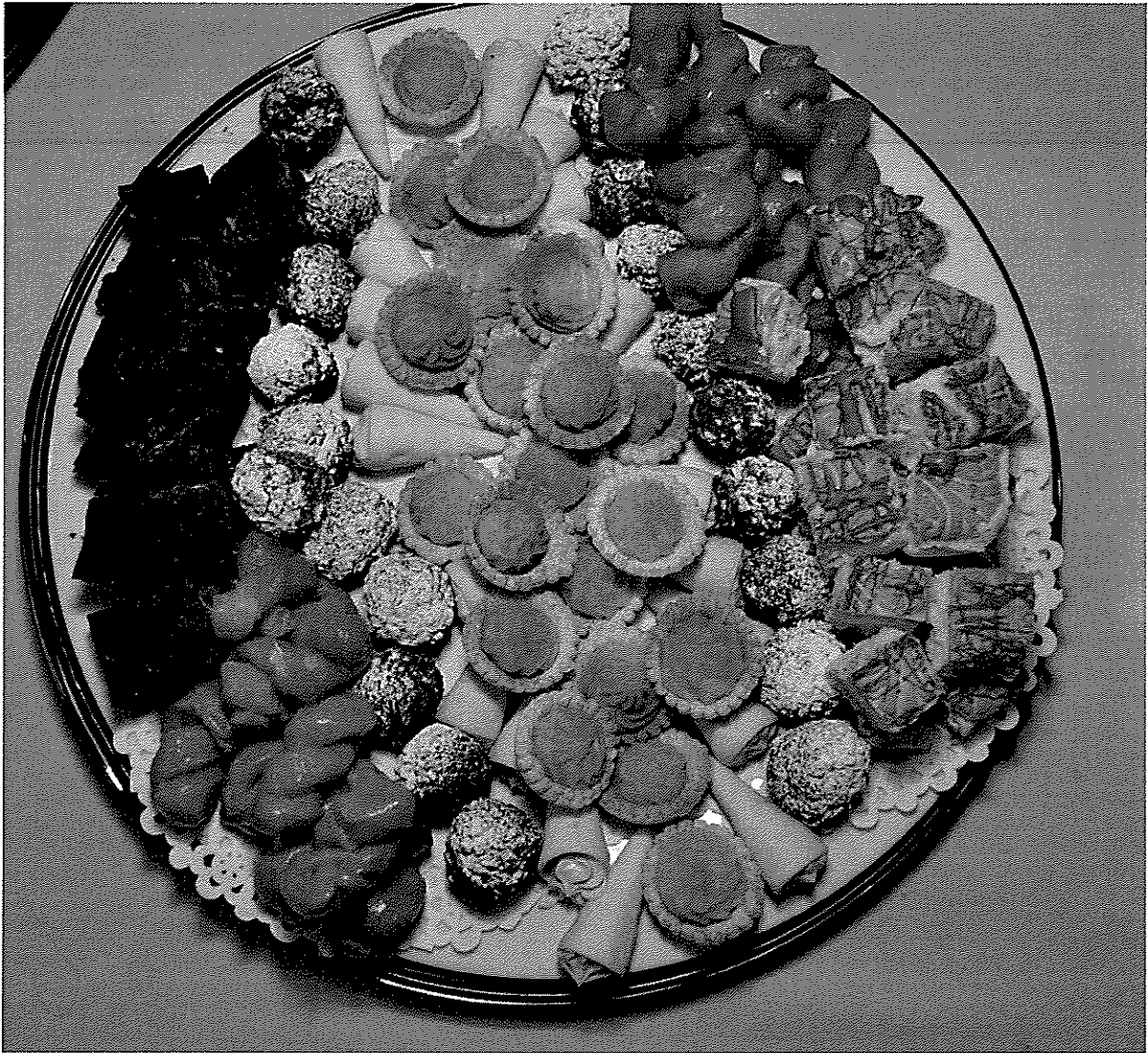
Fruit platter example

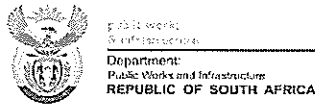
