

SPECIFICATION FOR SOURCING A SERVICE PROVIDER FOR BASIC PROJECT MANAGEMENT COURSE FOR PUBLIC SERVICE OFFICIALS

1. Purpose

The purpose is to identify a service provider to deliver a Basic Project Management Course for Public Service Officials who are new project managers or project administrators of the Cape Town Regional Office.

2. Background

The public service officials responsible for managing and administering the projects in the department would benefit from understanding the basics of project management. It is critical to source a service provider that will develop and deliver a training course that will equip the officials with the knowledge and skills required to perform their roles effectively.

3. Learning Outcomes

By the end of this course, participants should be able to demonstrate knowledge and understanding of:

- · Refine project organisational structure, profiles, roles and responsibilities,
- Determine integrated change control procedures.
- Produce an integrated project management plan document,
- Obtain approval for the integrated project management plan.

This <u>course must be aligned to unit standard: 243824</u>: Develop an integrated project plan for a simple to moderately complex project. NQF Level 5; Credits 8. After the successful completion of the course, participants will receive a Certificate of Competence.

4. Methodology

The methodology for the delivery of the course must include a combination of both theoretical and practical approaches. The course will be delivered through classroom sessions, group discussions, case studies, and practical exercises. Additionally, online resources such as videos, articles and quizzes should be included to cater for different learning styles.

5. Duration

The duration of the Basic Project Management Course will not exceed five days (class time). The course may include an extended period to allow for practical assessments while accommodating officials' work schedules.

6. Target Audience

The course is specifically designed for public service officials who are new to the role of the project manager or project administrator in the public service. A total of twelve (12) delegates have been identified to attend the course.

7. Qualification and Deliverables

The service provider must have the following qualifications and deliver on the following:

- Proven experience in delivering project management courses to public service officials.
- Qualified and experienced facilitator in project management.
- Experience working with government departments or entities.
- A strong understanding of public service operations and structure.
- · A training venue suitable and conducive to effective learning.
- Catering provision with tea/ coffee, water, drinks, snacks and lunch for the duration of training.
- Basic Project Management Course curriculum.
- Classroom materials and manuals for participants.
- · Online and computer resources for participants.
- Training evaluation methods and analysis.
- · Feedback and progress reports.


