# SPECIFICATION FOR SOURCING A SERVICE PROVIDER REPORT WRITING COURSE

### 1. Purpose

The purpose is to identify a service provider to deliver a SETA Accredited Report Writing training for **92** Public Service Officials in the Cape Town Regional Office.

### 2. Background

Our organisation recognizes the importance of effective report writing in the workplace. We understand that clear, concise, and well-structured reports play a crucial role in decision-making processes across all operations. The course will benefit officials who are responsible for developing and presenting information in report format, including investigative reports.

### 3. Learning Objectives

At the end of the programme, participants will gain essential knowledge and skills to be able to write professional and scientific reports that conform to conventional formats and communicate their message as effectively and efficiently as possible to all stakeholders and/or decision-makers. That is why we are on the lookout for a comprehensive training programme that covers the following key areas:

- 3.1 <u>Report Structure and Organisation:</u> A course that teaches participants the fundamental principles of creating professionally, logically structured reports.
- 3.2 <u>Clear and Concise Writing:</u> An emphasis on using plain language, avoiding jargon, and writing with clarity and simplicity.
- 3.3 <u>Data Analysis and Interpretation:</u> The ability to collect, analyze, and present data effectively within a report.
- 3.4 <u>Visual Aids and Graphics</u>: Teaching participants how to use visual aids, infographics, and charts to support data and enhance report readability.
- 3.5 <u>Proofreading and Editing:</u> Ensuring participants gain skills in proofreading and editing techniques to eliminate errors and enhance the overall quality of their reports.

### Method of assessment:

Use of formative and summative: Class tests/ assignments/ examination/ case studies/ group projects. After the successful completion of the course, participants will receive a certificate of competence. **Accreditation** by a relevant SETA on a unit standard set at NQF level 4 or above.

### 4. Training Methodology and Course Duration

Training delivery will follow a combination of both theoretical and practical approaches. The course will be delivered through **classroom sessions** which may include practical exercises. The duration of the course will be 2 days (class time) combined with practical workplace experience where necessary. A successful service provider is expected to provide a conducive training facility that includes catering provisions for coffee/tea, lunch, water, and drinks for all delegates.

**Take note:** An experienced facilitator with strong subject matter expertise in report writing training. Classroom material and manuals for delegates. Online and computer resources for delegates. Training evaluation methods and analysis. Feedback evaluation, attendance register and progress reports.

### 4.1 Delegates class breakdown

Due to the high number of participants, delegates will be grouped into 4 classes, each class with 23 delegates. Training will be scheduled and finalised within a period of 2 weeks (two classes per week). Your training proposal should take this into account.


