SPECIFICATION FOR SOURCING A SERVICE PROVIDER MS PROJECT 2019 BEGINNER TO ADVANCE COURSE

1. Purpose

The purpose is to identify a service provider to deliver an MS Project 2019 Beginner to Advanced training course for **18** Public Service Officials in the Cape Town Regional Office.

2. Background

Project management is viewed as a critical competence in the current business environment, for competitive and improved service delivery. It ensures timeously, within- budget and scope-complied project delivery to stakeholders' satisfaction.

Microsoft Project, is the most popular project management software to assist project managers with basic project management skills in developing plans, assigning resources to tasks, tracking progress, managing budgets, and analysing workloads and software for the successful delivery of projects. The use of MS Project in project management helps to contain a very high percentage of project information which otherwise would require several files to keep them. The programme can be customised to meet specific organisational contexts, and aligned with specific policies in Governmental institutions such as PMFA.

3. Learning Objectives

At the end of the programme, participants will be able to encourage and promote the application of basic principles and computer practice of project management across the entire project life cycle. Build a more solid computer practical foundation of project management knowledge, techniques and tools. Utilise project principles and practices inclusive of computer-based software applications in their work and enable participants to ultimately improve their project delivery in respect of time-frame, budget allocated and the required specifications.

On completion of this course, delegates will be able to:

1. Create a new project plan.
2. Create and organize tasks.
3. Create and assign work, material, and cost resources.
4. Finalizing a project plan.
5. Obtain approval to base the plan.
6. Update the project plan to reflect progress as you execute the project.

7. Monitor project progress in the project plan.
8. Adjusting the project plan to meet the time and cost objectives.
9. Controlling time and other constraints.
10. Create project reports to keep the stakeholders informed.
11. Create templates for future use.

Method of assessment:

Use of formative and summative: Class tests/ assignments/ Examination/ Case studies/ Group projects. After the successful completion of the course, participants will receive a Certificate of Competence. **Accreditation** by the Engineering Council of South Africa (ECSA) with 2 CPD Points and by the South African Council for the Projects and Construction Management Professions (SACPAMP) with 12 CPD points.

4. Methodology

The methodology for the delivery of the course must include a combination of both theoretical and practical approaches. The course will be delivered through **classroom sessions** and includes practical exercises.

5. Training and Course Duration

A successful service provider is expected to provide a conducive training venue that includes catering provisions for coffee/tea, lunch, water, and drinks for 18 delegates. The duration of the course will be at least 2 days (class time) combined with practical workplace experience where necessary.
