## **SPECIFICATION FOR SOURCING A SERVICE PROVIDER: LABOUR RELATIONS COURSE FOR MANAGERS, SUPERVISORS & EMPLOYEE REPRESENTATIVES**

### **1. Purpose**

The purpose is to identify a suitable and accredited training provider to deliver a Labour Relations course for **65 officials** of the Cape Town Regional Office.

### **2. Background**

Discipline management is one of the most critical aspects of labour relations. It is essential for effective service delivery to maintain discipline. Also equally important is the ability to effectively deal with incapacity and ill-health issues in the workplace. A comprehensive course that gives detailed insight into discipline in the workplace will assist staff in understanding their role in complying with labour relations legislation.

### **3. Learning Objectives**

By the end of this course, delegates will be able to:

- Understand the purpose, primary objects, application and interpretation of the Act.
- Have sound knowledge and confidence to implement the Labour Relations process,
- Understand the role of unions and employee representatives,
- To handle grievances in the workplace,
- Identify when to apply informal or formal discipline and the exact process to be followed in each case,
- Practice a range of disciplinary interventions short of dismissal that correct misconduct while also preserving relationships,
- Understanding whether on the available evidence, allegations are likely to be proven or not,
- Describe the appropriate dispute resolution route for dismissal disputes,
- Identify disputes referred to as unfair labour practice disputes
- Understand various codes of good practice and schedules
- Handling down an appropriate sanction.
- Understand and develop the ability to apply the underlying principles of the labour relations sector,

### **3.1 The course will cover but not be limited to the following topics:**

- Legislative Framework,
- Management of disciplinary hearings,
- Initiating disciplinary hearings,
- Chairing in a disciplinary hearing
- Manage absenteeism caused by ill – health,
- Conflict management in the workplace,
- Handling of grievances in the workplace
- Facilitate fair and just labour relations in an organisation,
- Manage and resolve labour disputes,
- Initiate actions that could prevent labour disputes,
- Implement management practices and
- Consider and apply relevant legislation and Jurisprudence.
- Disputes of rights and disputes of interests.
- Description of strikes, lockouts, picketing and refusal to bargain.
- Organisational rights disputes.
- Categories of unfair labour disputes.
- Facilitation of bargaining council.
- Code of good practice.

Learners should not be subjected to any practical assessment on the completion of the course and learners should be awarded a Certificate of attendance.

### **4. Training Methodology, Delivery and Duration**

  - (c) cancel the contract and claim any damages which it has suffered as a result of having to make less favourable arrangements due to such cancellation;
  - (d) recommend that the tenderer or contractor, its shareholders and directors, or only the shareholders and directors who acted on a fraudulent basis, be restricted from obtaining business from any organ of state for a period not exceeding 10 years, after the *audi alteram partem* (hear the other side) rule has been applied; and
  - (e) forward the matter for criminal prosecution, if deemed necessary.
