SPECIFICATION FOR SOURCING A SERVICE PROVIDER: VIRTUAL RECORDS MANAGEMENT COURSE

1. Purpose

The purpose is to identify a suitable and accredited training provider to deliver a Virtual Labour Relations course for **15 Public Service officials** of the Cape Town Regional Office.

2. Background

Data and Records management is one of the critical aspects of any organisation. Officials need to develop and improve their record and data management techniques and systems.

3. Learning Objectives

By the end of this course, delegates will be able to:

- Record and data management systems and the related processes
- Overview of the guidelines that relate to record and data management
- Record and data management: data, storage and retrieval aspects
- Planning a storage and retrieval system
- Implementing and maintaining a filing system
- Guidelines for retention and disposal of records
- Archiving and disposal of records
- Practical tips and templates for use at work
- Practical application to own work environment and related types of data that are worked with
- Good administrative practices and processes
- Using technology effectively for data management
- Quality Management Systems

3.1 The course should be based on any relevant unit standard set at minimum NQF level 4 (please attach proof of unit standard and accreditation). On completion of the course, learners will receive a Certificate of competency.

4. Training Methodology, Delivery and Duration

The methodology for the delivery of the course must include a combination of both theoretical and practical approaches. The course will be delivered through virtual classroom sessions with appropriate case studies and practical exercises. A training provider will provide the necessary tools and links to allow delegates to participate in the virtual classroom. The duration of the course should be 2 days (class time).

Take note: An experienced facilitator with strong subject matter expertise in Data and Records management relevant to the Public Service. Provide

learning material and manuals for delegates. Online and computer resources for delegates. Training evaluation methods and analysis. Feedback evaluation, attendance register and progress reports.

The course is targeted at officials dealing with records management in the Public Service, such as Administrators, Clerks and Supervisors. A total of 15 officials will be attending the training.
