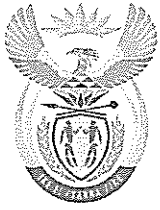

1. Purpose

The purpose is to identify an accredited trade test centre to conduct listed trade tests for Workshop officials in the Cape Town Regional Office.

2. Background

Training and Development interventions are an important function for any organisation. These interventions are critical for effective service delivery as they contribute to employee competence. The Department, through its Skills Development budget, is committed to ongoing training and development for its officials to assess the proficiency and skill level in any number of skilled trades that are applicable in the workplace.

We are looking for an accredited trade testing centre that complies with the Trade Test Regulations and Skills Development Act, 1998 to assist our officials by preparing, assessing and certification on the applicable listed trades.

3. Listed Trades

- 3.1 Preparation, ARPL and test – Plumbing for 2 officials
 - 3.2 Preparation, ARPL and test – Electrical for 6 officials
 - 3.3 Preparation, ARPL and test – Painting for 7 officials
