1. INTRODUCTION

- 1.1 The Department of Public Works and Infrastructure (DPWI) invites service providers (SP) to respond to the requirement to bid on the supply and delivery of crockery.

2. SUBMISSION REQUIREMENTS

- 2.1 Bidders must be registered on the Central Supplier Data Base (CSD). Bidders must attach documentary proof (screen print) of their registration to their tender at the time of submission.
- 2.2 The bidders must comply strictly with the Basic Conditions of Employment Act (BCEA), Act 75 of 1997, as amended, and any applicable sectorial determination in regard to salaries and wages
- 2.3 Bidders are to number and initial all attachments on the bid.

3. NON- COMPULSORY SITE BRIEFING

- 3.1 The bidder's representative can attend the non-compulsory briefing to view examples of some existing crockery units and ask questions about the specification.
- 3.2 The bidders must bring along with them identity documentation (SA ID) which will enable them to gain access at a National key point site.

4. CONTRACTUAL ASPECTS

 - (a) disqualify the person from the tendering process;
 - (b) recover costs, losses or damages it has incurred or suffered as a result of that person's conduct;
 - (c) cancel the contract and claim any damages which it has suffered as a result of having to make less favourable arrangements due to such cancellation;
 - (d) recommend that the tenderer or contractor, its shareholders and directors, or only the shareholders and directors who acted on a fraudulent basis, be restricted from obtaining business from any organ of state for a period not exceeding 10 years, after the *audi alteram partem* (hear the other side) rule has been applied; and
 - (e) forward the matter for criminal prosecution, if deemed necessary.
