

### TERMS OF REFERENCE

### 1. INTRODUCTION

- 1.1 The National Department of Public Works and Infrastructure (NDPWI) invites bids for the provision of cleaning staff to various sites in Western Cape as and when required on an ad hoc month basis.
- 1.1.1 On acceptance of the bid and instruction from NDPWI, the bidder will supply staff to commence work at any of the site given on in Schedule B on a monthly basis for the period indicated in the instruction.
- 1.1.2 The site information is provided as per Schedule B hereto.
- 1.1.2.1 Contractors will not be able to put in any claim for any work not done in the event we do not reach the <u>72 services</u> at the end of the 6 months period OR in the event we reach <u>72 services</u> before the end of the 6 months period, the contract will end immediately.

### 2. QUOTATION

- 2.1 The contract shall endure for a period of 6 months, calculated from formal acceptance of the successful bidder's offer.
- 2.1.1 Work will commence on instruction via e-mail from the NDPWI to supply staff to site for a set period. Example:
  - 1 Service = Supplying of 1 staff member for a period of 1 month to required site
  - 1 x Cleaner to Swellendam Magistrate office for 1 month starting 1 November 2020 =
     1 Service
  - 4 x Cleaners to 120 Plein Street for 2 months starting from 1 December 2020 until 31 January
     2021 = 8 Services
- 2.2 The NDPWI will not be held liable if no work is given due to a reduction in staff requirements.

### 3. STATUTORY COMPLIANCE

3.1 Bidders must comply with all applicable statutory and other regulatory stipulations, particularly the Basic Conditions of Employment Act, 75 of 1997 as amended and the applicable Sectoral Wage Determination promulgated from time to time. The Department reserves the right to reject any bid if it is of the opinion that the bid does not comply with the applicable wage determination.

### 4. FORM AND COMPOSITION OF CONTRACT

- 4.1 The contract will be subject to the General Conditions of Contract, as supplemented by the terms set out in this document, including all the schedules attached hereto.
- 4.2 The bid document, together with the attached schedules and other specifications contained in this document, shall constitute part of the Contract.

- 6.1 The working hours for the services to be rendered to NDPWI will determination in conjunction with the User Department.
- 6.2 The services required in terms of this bid. Absenteeism must be managed internally by the successful bidder and not hamper service delivery.
