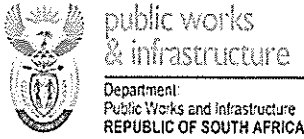

1. INTRODUCTION

The National Dept. of Public Works and Infrastructure (NDPWI) invites quotations for the high pressure cleaning of wheelie bins and bin storage areas.

2. DELIVERY PERIOD

The contract period will be for a period of 12 months on a month to month basis on receipt of official order. The successful bidder shall comply with the time frames in terms of delivery and collection.

3. SECURITY CLEARANCE

- 3.1 Bidders shall subject themselves to security clearance.
- 3.2 Bidders must submit any required documentation for purposes of security clearance within seven (7) days of request by the Department.
- 3.3 The Contractor shall ensure that all personnel engaged shall be cleared by the South African Police Services before they commence any duties on site, and shall provide proof of such clearance to the Department upon request.
