

### 1. INTRODUCTION

The National Dept. of Public Works and Infrastructure (NDPWI) invites quotations for the high pressure cleaning of wheelie bins and bin storage areas.

### 2. **DELIVERY PERIOD**

The contract period will be for a period of 9 months on receipt of official order. The successful bidder shall comply with the time frames in terms of delivery and collection.
