### TERMS OF REFERENCE

The Department of Public Works and Infrastructure, Cape Town Regional Office intends to appoint a service provider with relevant experience to roped access window cleaning.

#### 1. SCOPE OF CONTRACT

This contract is for the roped access cleaning of windows.

#### 2. PROVISION OF TRANSPORT

The Contractor shall provide all the necessary transport and labour for the duration of the contract.

#### 3. OBSERVANCE OF HEALTH REGULATIONS

All regulations prescribed by the State Health Department or by the local authority concerned, which have a bearing on this contract, must be observed meticulously by the contractor.

#### 4. PAYMENT

- (a) The Contractor shall be paid in arrears on submission of an account by him/her which shall be certified by the Officer in charge of the relative building or institution or his/her nominated Deputy, to the effect that the work reflected thereon are correct and that the service has been performed satisfactorily.
- (b) The contractor shall receive payment only for work actually performed.
- (c) The Government shall not be liable or responsible for payment of any extra work performed by the contractor without prior written permission of the Department of Public works.

#### 5. RATES TO INCLUDE TAX AND LABOUR

##### FIXED PRICE CONTRACT

This contract is a fixed priced contract and no adjustments shall be made for any increases or decreases on quoted rates, except for VAT rate adjustments.

#### 6. DOCUMENTS

The following documents must be read in conjunction with this tender.

- (i) Municipal by-laws and any special requirements of the Local Authority.
- (ii) Occupational Health and safety Act no. 85 of 1993
- (iii) Conditions of contract (PA 10 (FM)) and Addendum thereof

#### 7. PRODUCT SPECIFICATIONS

All cleaning products to be used by contractors must be environmental friendly, green products as stipulated by South African National Environments Management Act (NEMA). Unless otherwise specified, the products to be utilised in terms of the Contract must also comply with the relevant standards of the South African Bureau of Standards (SABS) and/or ISO9001.



## 8. EXTERNAL WINDOWS

Windows shall be washed clean and free of streaks, smears and visible soap residue. Accumulated dirt, paint specks or other foreign debris must be scraped from windows.

## 9. SUPPLIERS AND EQUIPMENT

The contractor must have use all equipment and supplies needed to carry out the window washing service specified, at no extra cost to Public Works. All equipment and supplies used must be capable of performing all operations in accordance with safety specifications.

## 10. EQUIPMENT AND SAFETY

Prior to commencing work, all contractor equipment shall be safety checked to confirm to Health & Safety regulations. Public Works may request the halt of any unsafe practices observed in carrying out the contracted service. This will in no way relieve the contractor of complying with the window cleaning schedule. No alcohol use of contractors on premises will be allowed at all times. Contractor shall provide all supervision on site to coordinate and inspect work. Successful bidder must adhere to the following: provide Health & Safety Plan, Fall protection Plan, contractor have a valid WCA certificate, Risk Assessment, ensure abseil equipment be certified safe to use, concrete where permanent anchor points thoroughly checked for required strength, engineer to certified that anchor points are safe before commencing cleaning operation.

## 11. SAFETY DATA SHEETS

Prior to starting, the contractor must provide Material Safety Data Sheet (MSDS). For any products used on site when required.

## 12. SAFETY AND OVERHEAD WORKS

Windows cleaning contractors shall close off areas and post signs indicating the areas are closed to pedestrian traffic when working over entrances, walkways or any areas where people /staff might cross below workers. Signs should indicate that operatives are working above. All equipment, apparatus or hoses on the ground level shall be marked off with cones and signs warning pedestrian traffic. Contractor shall provide all safety cones and signs. All workers while on duty shall be identified by uniform shirt or smock indicating the company name or logo in print large enough to be easily read.

## 13. DAMAGES

The contractor shall inform Public Works of any damages to windows or deterioration to frames.

- 4 The Tenderer accepts that the Employer may exercise any other remedy it may have in law and in the Contract, including a claim for damages for having to accept a less favourable tender as a result of any such disqualification due to misrepresentation or fraudulent information provided herein;
- 5 Any further documentary proof required by the Employer regarding the information provided herein, will be submitted to the Employer within the time period as may be set by the latter;
