## TERMS OF REFERENCE

### 1. INVITATION

- 1.1 The Department of Public Works and Infrastructure, Cape Town Regional Office intends to appoint a service provider with relevant experience to supply and deliver protective clothing.

### 2. PROJECT DELIVERABLES

Orders must be delivered in full as per the quantity and delivery.

- NDPWI will return any wrong deliveries at the cost of the service provider.

### 3. SPECIAL CONDITIONS

- It is expected that all deliveries must be accompanied by an original invoice and a delivery note stating the official purchase order number against which the delivery has been effected.

Should the Supplier fail to deliver in the required timeframe, the Department reserve the right to source items from other service providers and recover any difference in cost from the appointed service provider.

Government Procurement General Conditions of contract (GCC) as issued by National Treasury will be applicable on all instances

### 4. BASIS OF CONTRACT

- 4.1 The general condition of contract of contract (2010 version, issued by National Treasury) as supplemented by terms and condition set out in the terms of reference, shall constitute the basis of the contract between the parties.
- 4.2 In the event of contradiction between the two documents Terms of Reference shall prevail.

### 5. ANNEXURE A: PRICING GUIDELINE AND SCHEDULE

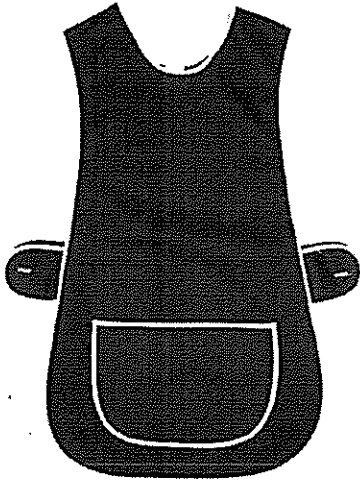

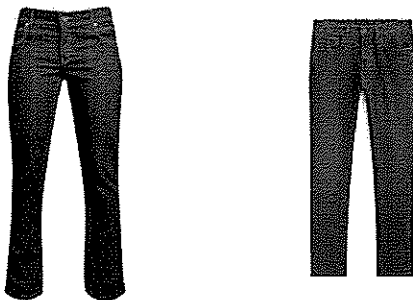
