# TERMS OF REFERENCE FOR GROOTE SCHUUR HOUSE INSURANCE

## 1. OBJECTIVE

The Department of Public Works (DPW) invites bids for the appointment of an Insurance Broker or Insurance Company to insure the Groote Schuur House/Museum and its contents. The insurance should cover the house on all risks basis (e.g. fire /peril/accidental loss and damage). It must be noted that the Groote Schuur House at present is not used as a residence but as the museum although it is not officially declared as a museum. The collection was declared Cultural Treasure and the house declared a National Monument.

## 2. DELIVERABLES AND TASKS

**The House Contents:** The contents of Groote Schuur House consist of two collections - Rhodes and the Groote Schuur Collection which includes items from the Department of Public Works.

The Rhodes collection consists of antique items many of which have been declared by SAHRA and includes furniture, artwork, tapestries, metal, ceramics, books and maps.

The Groote Schuur House Collection consists of similar items but includes newer pieces while the DPW consists of more functional and everyday items.

## **GROOTE SCHUUR HOUSE**

The house remains largely as it was left to the Nation in 1911. It had been renovated and extended by Cecil John Rhodes with the architect Herbert Baker in 1893-4 and again in 1896 after a fire. A few alterations were made during the 20<sup>th</sup> century, in 1993 the house was declared a National Monument by the National Monuments Council (later SAHARA-The South African Heritage Resources Agency). There are unique features in the house, such as the Spanish leather panels from the 17<sup>th</sup> century on the walls of the drawing rooms and copies in wood of the Zimbabwe Bird on the bannisters of the main staircase. All the paneling, doors and floors are made in Burmese teak which is now an endangered species and which can only be replaced at considerable cost. The house has 35 rooms (not all furnished) and four lobbies.

### **3. CONTRACTUAL ASPECTS**

- 3.1 The contents of this document shall be deemed to constitute the Special Conditions of Contract applicable to this bid, and shall be read together with the General Conditions (PA10) of the Contract issued in accordance with Chapter 16A of the Treasury Regulations.
- 3.2 Where, however, the Special Conditions of contract are in conflict with General Conditions of Contract, the Special Conditions of Contract shall prevail.
- 3.3 The bid document, together with the specifications contained in this document, shall constitute part of the Contract.
- 3.4 Bidders shall not perform any work or render any services in terms of the Contract unless in receipt of a written instruction to this effect by the Department.
