SPECIFICATIONS FOR TREE FELLING & PRUNNING SERVICES AT STATE PROPERTIES

1. DESCRIPTION OF SERVICES

AREAS:

- MOSSELBAY SAPS
- DROSTDY- DOJ -HOUSE

LOCATIONS:

- 2C George Rd : Mosselbay SAPS
- 31 Church Street –Drostdy Mosselbay

SERVICES : Tree Felling and Pruning Services and Waste Removals.

Once Off Service.

2. SCOPE OF SERVICE

2.1 Mosselbay SAPS

- 2.1.1 Fell the trees to the ground level and treat all stumps with a suitable herbicides.
- 2.1.2 Caution to be exercised when cut the tree in close proximity to the fence line and any high voltage line.
- 2.1.3 Prune trees down by 50% such tree will be marked by the project leader.
- 2.1.4 Prune all dry and dead leaves from the palm plants.
- 2.1.5 Treat all cut surfaces on pruned trees with a suitable sealant.
- 2.1.6 All vegetation waste/dumping materials must be removed from the site immediately.

2.2. Drostdy (DOJ)

- 2.2.1 Fell trees down to the ground level and treat all stump with a suitable herbicide.
- 2.2.2 Prune trees down by 50%, such trees will be marked by the project leader.
- 2.2.3 Remove Lantana shrubs.
- 2.2.4 Remove Bamboo reeds.
- 2.2.5 Remove Bougainvillea hedge plants.
- 2.2.6 Treat cut surfaces /stumps with suitable herbicides where necessary.
- 2.2.7 Treat cut surfaces on pruned trees with a suitable sealant.
- 2.2.8 Caution to be exercised when cut the tree in close proximity to the built structure, fence and high voltages power line.
- 2.2.9 All vegetation cutting waste must be removed immediately to the registered landfill

3. INSTRUCTIONS

- 3.1 Please use every precaution when executing the tree works.
- 3.2. Treat all cut surfaces with appropriate herbicide.
- 3.3. Remove all waste materials and dead plant debris immediately.

4. GENERAL CONDITIONS

- 4.1 The Contractor shall provide all materials, labour and equipment deemed necessary
- 4.2 Staff must be overseen at all times by a supervisor with suitable Horticultural knowledge
Staff may not enter any area which is not clearly work-related.
- 4.3 Service providers should note that service offered must be in strict conformity with the relevant specifications.
- 4.4 Any quotation submitted shall remain valid, irrevocable and open for acceptance by the Department for a period of thirty (30) days from the closing date.
- 4.5 NDPW & I horticulture reserves the right to inspect equipment, machinery and Premises of services provider who will be appointed.

5. OBSERVANCE OF LAWS AND REGULATIONS

5.1 Observance of Laws and Regulations

- 5.1.1 The service provider shall secure all permits and licenses imposed by law and ordinance, pay all charges and fees, and give all notices necessary and incidental to the due and lawful prosecution of the work regarding the obstruction of streets and driveways, maintaining signals and open passageways, and protecting the same where exposed.
 - 5.1.1.1 **Hours of Work:** The service provider shall perform the work during weekdays and within operating hours 08:00 till 16:00 unless requested by a Departmental official to deviate.
 - 5.1.1.2 **Equipment:** The service provider is responsible for providing, maintaining & transporting all necessary equipment in connection with the program of plot clearing described in this Agreement. All other tools and supplies necessary for performing the work required by this Agreement will be provided by the service provider.
 - 5.1.1.3 **Obstruction of Streets and Right-of-Ways:** The service provider will arrange to keep sidewalks open for traffic whenever possible and will block portions of streets only when deemed necessary to protect private property. Warning signs and barricades shall be furnished and erected by the service provider when warranted. It is the service provider's responsibility to remove all surplus material and debris from streets as work progresses in order that the public will have adequate use of the affected streets.

- 5.1.1.4 The service provider shall have in its employ, or under its control, sufficient qualified and competent personnel to perform work promptly and in accordance with a schedule or work program, as approved by the Departmental official.
- 5.1.1.5 The service provider shall employ only such workers as are skilled in the tasks to which they are assigned. Workers shall act appropriately and professionally at all times. Offensive language, gestures or actions while in this facility are not acceptable. The Department may require the service provider not to assign any employee the Department deems incompetent, careless, insubordinate, or otherwise objectionable to work on these premises.

5.2 SAFETY STANDARDS

- 5.2.1 The service provider's employees shall follow all applicable safety standards including operating all equipment in conformance with the manufacturer's operating instructions for each, and in compliance with OSHA standards and requirements.
