



2. SCOPE OF SERVICE

2.1 Police Resident DISA Court

- 2.1.1 Fell the five tree (eucalyptus sp) to the ground level and treat all stumps with a suitable herbicides.
- 2.1.2 Caution to be exercised when cut the tree in close proximity to the fence line and any high voltage line.
- 2.1.3 Prune five trees (pupulus sp) down by 50% such tree will be marked by the project Leader.
- 2.1.4 Treat all cut surfaces on pruned trees with a suitable sealant.
- 2.1.5 All vegetation waste /dumping materials must be removed from the site immediately.

2.2 Mitchells Plain SAPS

- Fell one tree to the grounds level and treat the stump with a suitable herbicides
- Caution to be exercised when cut the tree in close proximity to the fence line and any high voltage line.
- All vegetation waste /dumping materials must be removed from the site immediately.

3. INSTRUCTIONS

- 3.1 Please use every precaution when executing the tree works.
- 3.2. Treat all cut surfaces with appropriate herbicide.
- 3.3. Remove all waste materials and dead plant debris immediately.

4. GENERAL CONDITIONS

- 4.1 The Contractor shall provide all materials, labour and equipment deemed necessary
- 4.2 Staff must be overseen at all times by a supervisor with suitable Horticultural knowledge
