1. DESCRIPTION OF SERVICES

Area : Citrusdal, Clan William, Klawer, Porterville
: Vredenburg, Vredendal, and Van Rynsdorp

Services : 6 x Services Month to Month on each area

2. SCOPE OF A COMPLETE SERVICES

- 2.1 Mowing and trimming of all lawn areas including the edges, inside fence and the outside verge, including vacant area that are part of the courts erf ,if any, once a month.
- 2.2 Removals of paper, plastics, tins from all plants and weeds plants beds and loosen the soil, including vacant areas that are parts of the courts erf, if any, at each services.
- 2.3 Cultivation of flower beds, water plants beds and lawns area at each services.
- 2.4 Prune and trim all plants materials which pose security risk, obstruct the traffic and camera.
- 2.5 Prune and hedged all plants materials along the border fence when the need arises. Pruning shall comprise of trimming of plant materials where maybe hanging over loose (e.g. electrical poles, over the fence, or obstructing property and signage)
- 2.4 Apply herbicide spraying on hard surfaces, (Weed control on the pavement and tarred road)
- 2.5 The services includes all courtyards (internal and externals)

- 2.6 All invoices to be accompanied by a confirmation of services from court /office manager of work completed per services rendered.
- 2.7 Unbroken consecutive days of services will be regarded as one complete services and thus paid accordingly.
- 2.8 Month to month services will be rendered according to the department discretions.
- 2.9 The services provider needs to sign in and out with the security services on the commencement and completion of the services on the day.
- 2.10 All services to commence at the beginning of the new month upon receipt of the suppliers advice or instructed otherwise by the department.
- 2.11 All vegetation waste/dumping materials must be removed from the site immediately.

3. GENERAL CONDITIONS

- 3.1 The Contractor shall provide all materials, labour and equipment deemed necessary
- 3.2 Staff must be overseen at all times by a supervisor with suitable Horticultural knowledge. Staff may not enter any area which is not clearly work-related.
- 3.3 Service providers should note that service offered must be in strict conformity with the relevant specifications.
- 3.4 Any quotation submitted shall remain valid, irrevocable and open for acceptance by the Department for a period of 56 days from the closing date.

4 OBSERVANCE OF LAWS AND REGULATIONS

4.1.1. Observance of Laws and Regulations

The service provider shall secure all permits and licenses imposed by law and ordinance, pay all charges and fees, and give all notices necessary and incidental to the due and lawful prosecution of the work regarding the obstruction of streets and driveways, maintaining signals and open passageways, and protecting the same where exposed.

4.1.2 Hours of Work:

The service provider shall perform the work during weekdays and within operating hours 08:00 till 16:00 unless requested by a Departmental official to deviate.

4.1.3 Equipment:

The service provider is responsible for providing, maintaining & transporting all necessary equipment in connection with the program of garden maintenances described in this Agreement. All other tools and supplies necessary for performing the work required by this Agreement will be provided by the service provider.

4.1.4 **Obstruction of Streets and Right-of-Ways:**

The service provider will arrange to keep sidewalks open for traffic whenever possible and will block portions of streets only when deemed necessary to protect private property.

Warning signs and barricades shall be furnished and erected by the service provider when warranted.

It is the service provider's responsibility to remove all surplus material and debris from streets as work progresses in order that the public will have adequate use of the affected streets.

4.1.4a The service provider shall have in its employ, or under its control, sufficient qualified and competent personnel to perform work promptly and in accordance with a schedule or work program, as approved by the Departmental official.

4.1.4b The service provider shall employ only such workers as are skilled in the tasks to which they are assigned. Workers shall act appropriately and professionally at all times. Offensive language, gestures or actions while in this facility are not acceptable. The Department may require the service provider not to assign any employee the Department deems incompetent, careless, insubordinate, or otherwise objectionable to work on these premises.

4.2 **Safety Standards**
