Cargo Transport and Clearance for the Departure and Return Voyage for Gough Island Annual Maintenance.

DESCRIPTION:

Transportation, Cargo Clearance and offloading of containers / crates of varies sizes, containing maintenance materials / tools / equipment from the S.A. Agulhas II at East Pier Shed, V & A Waterfront/(Cape Town Airport/ OR Thambo Airport) and the transportation thereof to Customs House Cape Town after each Voyage.

Departure and Return Journey – During the 2022/2023 financial year (and any unforeseen or unscheduled voyage) there will be a scheduled maintenance (departure and return) voyages from the Gough Island.

Maximum prescribed weight up to 3 tons per blue container / crate or loose cargo.

The successful tenderer must quote on the transportation and cargo clearance of said containers/ crates from East Pier Shed V & A Waterfront/(Cape Town Airport/ OR Thambo Airport) to Customs House Cape Town or any other berth within the Cape Town Harbour area.

The successful tenderer will receive a Cargo List as well as an itemized packing list, per container, to assist with the cargo clearance procedures.

Proximate Offloading Dates: Please note these dates may change due to unforeseen circumstances, such as severe adverse weather conditions etc.

Departure Date: 18 August 2022

Return Date: October 2022 (each year dates do vary)

COVID 19 Protocol (Rules and regulations) should be adhered to at all times.

The successful tenderer may be requested to decontaminate / disinfect the cargo before loading and once offloaded from the vessel.

Containers/ crates can vary in shape and size. The standard metal container in use is 2.46m (L) x 1.5m (H) x 1.04m (W).

Containers can be manufactured from metal, plastic, pipe and wood bundles as well as treated wood. A bundle may consist of treated wood, plastic pipes, Steel rods, square tubing, pipe as well as other awkwardly shaped materials.

The successful tenderer is advised to make use of suitable interlinked trucks due to time constraints when loading / off-loading the stipulated cargo.

The amount of containers might vary from voyage to voyage. The unit rate will be fixed for the entire duration of the contract.

The successful tenderer may be requested to assist the Department with Transportation, Cargo Clearance and Loading of Containers containing maintenance material / tools / equipment on any Vessel, at any berth within the Cape Town Harbor area and / or Flight, from Cape Town International Airport, destined for Gough Island for an emergency voyage.

The successful tenderer should also note that at times DPW works on an emergency and may be requested that they undertake cargo clearance and transport within 2-3 days.

The successful tenderer is expected to adhere to the allocated DPW loading/offloading times by DEA.
