





### TERMS OF REFERENCE FOR APPOINTMENT OF AN AUCTIONEER TO RENDER AUCTIONING SERVICES ON BEHALF OF THE DEPARTMENT OF PUBLIC WORKS AND INFRASCTURE (NDPWI)

### 1. BACKGROUND

The Department of Public Works and Infrastructure is required by regulation to dispose assets that no longer contribute toward service delivery objectives of the department. The types of moveable assets include but not limited to Computer Equipment, Office and Furniture Equipment, Audio Visual Equipment, Kitchen Appliances, Domestic Furniture and Equipment, Soft Furnishing and Linen, Vehicles etc.

### 2. CONTRACT PERIOD

The expected duration of the project is for a once – off service from the date of signing service level agreement.

### 3. PROJECT OBJECTIVE

NDPWI wishes to invite auctioneers registered with the **South African Institute of Auctioneers** to assist the Department with disposing movable assets ie Equipment,

Audio Visual Equipment, Kitchen Appliances, Domestic Furniture and Equipment, Soft

Furnishing and Linen, Vehicles etc.



### 4. SCOPE OF THE REQUIRED SERVICE


The service provider must carry out the auction at DPWI Regional Office at Customs House, Cape Town.

To follow up all due processes of auctioning and management of the process as follows:

- The service provider will be responsible for advertising auction in at least one local newspaper.
- Facilitate viewing of items to be auctioned at least two days before the auction.
- · Prepare and sort items into lots for auction
- Draft auction roll
- Facilitate viewing of items by the public to be auctioned
- · Facilitate auctioneering of items.
- Ensure all monies are collected.
- The service provider will be responsible all processed and reconcile back to the asset sold.
- Payment to DPWI for items auctioned according to percentage in bid documents.
- Proceeds from the auction must be paid into the department's bank account within 7 days after sign off the process by the Departmental's official.
- Upon completion of auction a close out report should be handed to DPWI within 10 working days and clear site auction within 7 days after auction.
- All costs arising from the above will be borne by the service provider.

### 6. Company Experience

The company must have experience in successfully auctioning movable assets in the recent past 2 years (July 2020 to Date ) and must be registered with the South African Institute of Auctioneers and should also include contactable references.



### 7. Resource Requirements

### 7.1 Team Leader

- Team leader and Director must hold a National Certificate in Auctioning.
- Minimum of 2 years experience in the auctioneering industry.
- Service provider must submit copies of qualifications and CV of its Team Leader.

### 7.2 Personnel

Successful Bidders must provide proof of recent auctions conducted successfully in the past two years.

Provide an appointment letter with reference letter clearly stating the employer, contact details, the contract duration amount. The Department reserve the right to verify the reference during any stage of the procurement.

Personnel will be required to disassemble, relocate and reassemble furniture and equipment. Bidders to reflect how many personnel will be made available for the duration of each auction.

The Department reserves the right to request removal of any personnel employed by the bidder from site should the service not be in accordance with Departmental Regulations.

7.3 The successful service provider will report to the Deputy Director: Asset Management during the auctioning processes. The final auction report will be submitted to the Director: SCM after auction.



### 8. Payment of Monies to DPWI

The service provider will be responsible for paying over to DPWI (by bank transfer), all monies received from sales at auction (less the agreed commission deduction), within (7) days of the date of the auction. All supporting documentation must be provided.

### 10. Role and Responsibility

DPWI will provide support and facilitation of the sales process with the following:

- · Access to all assets identified for disposal.
- · Access to all pertaining documentation to facilitate sales / customs procedures
- Access to working space and utilities as needed or available.

### 11. Equipment

The service provider needs to specify what equipment is to be utilized for packing and removing the auction items eg trolley, ladder.

### 12. Pricing

- The prices must be based on a percentage charged by the service provider on the total sales received at auction.
- The percentage charged will be inclusive of all costs associated with the auction (including advertising, packaging, removal and transportation) and must be inclusive of VAT.
