

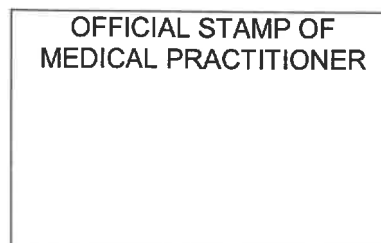

INTRODUCTION
