Scope of Work

The complaint request for the service of the air conditioner(s), as above etc. The service provider shall also compile a service report of the work done and must be submitted together with a signed and stamped job card by the user Department official in charge.

The service and repairs of the equipment shall be done professionally and in a proper manner by a competent Technician.

Occupational Health and Safety Act, 1993(Act no.85 of 1993) as amended shall be adhered to.

All equipment and materials shall be repaired, serviced and installed strictly in accordance with the manufacturer's specifications, instructions, code of practice.

All equipment, component parts, fittings and materials shall conform in respect of quality, SABS or SANS specification.

Noise and Vibration:

The equipment shall be mounted on vibration isolators of the correct type and selection depending on deflection requirements and vibration frequency.

Anti-vibration connections shall be used on the pipework (where necessary) where it joins vibrating equipment such as compressor(s), etc.

Mechanical and electrical checks shall be done prior commissioning.

Ventilation system(s) & Self-contained air conditioning units

- Inspect and clean all duct work.
- Check tightness of all securing bolts.
- Clean all filters and only replace when necessary.
- Check bearings of fan motors and lubricate.
- Repair any defects on the system.
- Clean fan blades and balance when necessary.
- Check fans, speed controls and fan motor.
- Clean the air intake screen.
- Clean filters or replace filters inly if necessary.
- Clean housing, ensure that all panels are properly secured and door panels close properly.
- Check settings and operation of all pressure switches and rest if required.
- Check settings and operation of all safety switches, i.e. LP & HP switches, oil pressure switches, etc.
- Check setting and operation of thermostats. Check all different timers
 & reset if required.
- Check running current of fans, compressors, settings and operation of overloads.
- Check tightness of all electrical connections.
- Check condition of all cables, whether cables are neatly strapped and reposition if required.



- Check oil acidity.
- Ensure correct operation of emergency stop.
- Carry out a leak test on all refrigeration piping and components inclusive of evaporator and condenser.
- All leaks shall be repaired or replaced provided a complaint is being logged.
- The filter drier shall be replaced when blocked.
- Check compressor vibration mount, etc.
- Check the refrigerant charge sight glass being clear or flashing.
- Check moisture indicator.
- Clean condensate tray and test drainage operation.
- Clean evaporator and condenser blades and check unbalance thereof.
- Check all the service valves for full operation, replace caps if missing.
- The superheat setting of the thermostatic expansion valve (TEV) shall be checked and also adjusted if required.
- Check pressure drops over filters and the air quantity over filters.

NOTES:

The purpose of this document is to:

- Draw special attention to certain general conditions applicable to government bids, contracts and orders: and
- To ensure that clients be familiar with regard to the rights and obligations of all parties involved (ii) in doing business with government.

In this document words in the singular also mean in the plural and vice versa and words in the masculine also mean in the feminine and neuter.

- The General Conditions of Contract will form part of all bid documents and may not be amended.
- Special Conditions of Contract (SCC) relevant to a specific bid should be compiled separately for every bid (if applicable) and will supplement the General Conditions of Contract. Whenever there is a conflict, the provisions in the SCC shall prevail.

General Conditions of Contract

1. Definitions

- 1. The following terms shall be interpreted as indicated:
- 1.1. "Closing time" means the date and hour specified in the bidding documents for the receipt of bids.
- 1.2. "Contract" means the written agreement entered into between the purchaser and the supplier, as recorded in the contract form signed by the parties, including all attachments and appendices thereto and all documents incorporated by reference therein.
- 1.3. "Contract price" means the price payable to the supplier under the contract for the full and proper performance of his contractual obligations.
- 1.4. "Corrupt practice" means the offering, giving, receiving, or soliciting of any thing of value to influence the action of a public official in the procurement process or in contract execution.
- 1.5. "Countervailing duties" are imposed in cases where an enterprise abroad is subsidized by its government and encouraged to market its products internationally.
- "Country of origin" means the place where the goods were mined, grown or produced or from which the services are supplied. Goods are produced when, through manufacturing, processing or substantial and major assembly of components, a commercially recognized new product results that is substantially different in basic characteristics or in purpose or utility from its components.
- 1.7. "Day" means calendar day.
- 1.8. "Delivery" means delivery in compliance of the conditions of the contract or order.
- 1.9. "Delivery ex stock" means immediate delivery directly from stock actually on hand.
- 1.10. "Delivery Into consignees store or to his site" means delivered and unloaded in the specified store or depot or on the specified site in compliance with the conditions of the contract or order, the supplier bearing all risks and charges involved until the supplies are so delivered and a valid receipt is obtained.
- 1.11. "Dumping" occurs when a private enterprise abroad market its goods on own initiative in the RSA at lower prices than that of the country of origin and which have the potential to harm the local industries in the RSA.
- 1.12. "Force majeure" means an event beyond the control of the supplier and not involving the supplier's fault or negligence and not foreseeable. Such events may include, but is not restricted to, acts of the purchaser in its sovereign capacity, wars or revolutions, fires, floods, epidemics, quarantine restrictions and freight embargoes.
- 1.13. "Fraudulent practice" means a misrepresentation of facts in order to influence a procurement process or the execution of a contract to the detriment of any bidder, and includes collusive practice among bidders (prior to or after bid submission) designed to establish bid prices at artificial non-competitive levels and to deprive the bidder of the benefits of free and open competition.
- 1.14. "GCC" means the General Conditions of Contract.
- 1.15. "Goods" means all of the equipment, machinery, and/or other materials that the supplier is required to supply to the purchaser under the contract.



- 1.16. "Imported content" means that portion of the bidding price represented by the cost of components, parts or materials which have been or are still to be imported (whether by the supplier or his subcontractors) and which costs are inclusive of the costs abroad, plus freight and other direct importation costs such as landing costs, dock dues, import duty, sales duty or other similar tax or duty at the South African place of entry as well as transportation and handling charges to the factory in the Republic where the supplies covered by the bid will be manufactured.
- 1.17. "Local content" means that portion of the bidding price which is not included in the imported content provided that local manufacture does take place.
- 1.18. "Manufacture" means the production of products in a factory using labour, materials, components and machinery and includes other related value-adding activities.
- 1.19. "Order" means an official written order issued for the supply of goods or works or the rendering of a service.
- 1.20. "Project site" where applicable, means the place indicated in bidding documents.
- 1.21. "Purchaser" means the organization purchasing the goods.
- 1.22. "Republic" means the Republic of South Africa.
- 1.23. "SCC" means the Special Conditions of Contract.
- 1.24. "Services" means those functional services ancillary to the supply of the goods, such as transportation and any other incidental services, such as installation, commissioning, provision of technical assistance, training, catering, gardening, security, maintenance and other such obligations of the supplier covered under the contract.
- 1.25. "Written" or "in writing" means handwritten in ink or any form of electronic or mechanical writing.

2. Application

- 2.1 These general conditions are applicable to all bids, contracts and orders including bids for functional and professional services, sales, hiring, letting and the granting or acquiring of rights, but excluding immovable property, unless otherwise indicated in the bidding documents.
- 2.2. Where applicable, special conditions of contract are also laid down to cover specific supplies, services or works.
- 2.3. Where such special conditions of contract are in conflict with these general conditions, the special conditions shall apply.

3. General

- 3.1. Unless otherwise indicated in the bidding documents, the purchaser shall not be liable for any expense incurred in the preparation and submission of a bid. Where applicable a non-refundable fee for documents may be charged.


