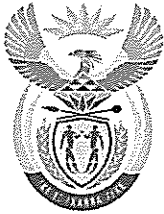

## TERMS OF REFERENCE:

### APPOINTMENT OF A SERVICE PROVIDER TO DELIVER COMBINED TRAINING INTERVENTION: HEALTH AND SAFETY REPRESENTATIVE COURSE AND FIRST AID LEVEL 1

#### 1. Purpose

The Directorate: Human Resources Development requires the appointment of an accredited and credible service provider to deliver combined training: **HEALTH & SAFETY REPRESENTATIVES COURSE AND FIRST AID LEVEL 1** for the officials in the Cape Town Regional Office.

#### 2. Background

2.1 The Department of Public Works has in line with the Skills Development Act and Human Resources Development Strategy conducted a training needs analysis for the current financial year and approved a Training Plan for implementation of needs.

2.2 As per the Occupational Health and Safety Act 85 of 1993, employers are required by law to ensure that they provide a workplace that is safe and free from harm to the safety, health, and wellbeing of employees, as far as reasonably practicable. It is crucial for that an organisation must have a dedicated health and safety team with the necessary accredited training to carry out their duties.

#### 3. Expected Outcomes/ Deliverables

##### 3.1 Health and Safety Representative Course Content – duration 2 days

- Explaining and the understanding of the Occupational Health and Safety Act 85 of 1993.
- Understanding the various terminologies and definitions.
- Duties of the employers (Sec 8) and employees (Sec 14) of the OHS Act 85 of 1993.
- Safety Representatives (Sec 17 & 18) and their functions (Sec 18) of the OHS Act 85 of 1993.
- Safety Committees (Sec 19 & 20) and their functions (Sec 20) of the OHS Act 85 of 1993.
- Effectively identifying hazards, unsafe acts and unsafe conditions.
- Effective HSE inspections at the workplace.
- Variables that influence Occupational Health and Safety.
- Effective Communication of H&S requirements.
- Safety Principles & Practices at workplaces.

- Effective HSE committee meetings and minute taking.
- Environmental Awareness.
- Practical work or assessment

### 3.2 **First Aid level 1 Course Content – duration 2 days**

- Principles of First Aid and Safety;
- Artificial Respiration;
- One-Rescuer CPR;
- Choking;
- Wounds & Bleeding;
- Shock, Unconsciousness and Fainting;
- Fractures;
- Burns;
- Head and Spinal Injuries;
- Any additional first aid level 1 offerings

## 4. **Course venue, number of delegates and catering provisions**

4.1 The training shall be facilitated face to face in a classroom setting over a period of four (04) days allowing interaction with and amongst learners. Two days shall cover facilitation of the Health & Safety Representatives course while another two days shall cover First Aid level 1 course.

4.2 A total of eight (08) officials are set to attend this combined training.

4.3 A suitable, conducive learning environment/ training facility, with training equipment (computers and connectivity) and material must be provided by the training provider for attendance in the Cape Town CBD. The successful training provider will also be expected to provide catering for tea and lunch this must include coffee/ tea/ water/ drinks for the training duration. The quotation for the training must be inclusive of the venue and catering provisions. Training providers must indicate and provide venue location/ address where the training will take place.

## 5. **Service Provider Accreditation and Learner Certification**

A service provider shall provide proof of accredited with the Department of Labour and on completion of the course learners / attendees shall be presented with a relevant SETA accredited certificates.
