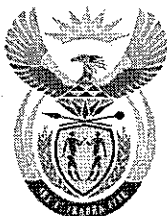

SPECIFICATION FOR SOURCING A SERVICE PROVIDER FOR FLEET MANAGEMENT COURSE FOR NATIONAL DEPARTMENTS.

1. Purpose

The purpose is to identify a service provider to deliver a Fleet Management Course for Public Service Officials involved in Transport administration in the Cape Town Regional Office.

2. Background

The public service officials responsible for managing and administering Transport in the department would benefit from understanding transport administration and procedures. It is critical to source a service provider that will develop and deliver a training course that will equip the officials with the knowledge, skills attitude and values to understand and apply the principles and concept of fleet management in the Public sector.

3. Learning Outcomes

By the end of this course, participants should be able to demonstrate knowledge and understanding of:

- Understand and apply the generally accepted appropriate vehicle fleet management principles.
- Apply knowledge of Logistics, supply chain management, technical and maintenance activities;
- Select appropriate vehicles and methods of acquisition and financing
- Execute the fleet Management policy of the undertaking

After the successful completion of the course, participants will receive a Certificate of Competence.

4. Methodology

The methodology for the delivery of the course must include a combination of both theoretical and practical approaches. The course will be delivered through classroom sessions and practical exercises.

5. Duration

The duration of the course will not exceed four days (class time) combined with practical workplace experience.

6. Target Audience

The course is specifically designed for public service officials who are new to the role of the Fleet administrator in the public service. A total of nine (9) public service officials have been identified for this training.

- Qualified and experienced facilitator in Fleet Management.
- Experience working with government departments or entities.
- A strong understanding of public service operations and structure.
- A training venue suitable and conducive to effective learning.
- Catering provision with tea/ coffee, water, drinks, snacks and lunch for the duration of training.
- Basic Fleet Management for Government Department curriculum.
- Classroom materials and manuals for participants.
- Online and computer resources for participants.
- Training evaluation methods and analysis.
- Feedback and progress reports.
