

SPECIFICATION FOR SOURCING A SERVICE PROVIDER SKILLS DEVELOPMENT COMMITTEE TRAINING COURSE

1. Purpose

The purpose is to identify a service provider to deliver SETA Accredited Skills Development training for **15** Public Service Officials in the Cape Town Regional Office.

2. Background

We are seeking a reputable training provider to implement training services for our Skills Development Committee. The Skills Development Act and the Department's Training Policy provide for the establishment of a training committee to encourage broader employee consultation and participation in developing and enhancing skills within our organisation. We aim to source a training provider that can deliver high-quality training programs to upskill and develop our officials.

3. Learning Objectives

At the end of the programme, participants will gain essential knowledge and skills to meet all the legislative requirements, conduct effective Training Committee meetings and ensure effective implementation of the Workplace training plan as prescribed by legislation. The following key areas will be covered:

- The Employment Equity Act towards skills development:
- The current skills development legislation in South Africa;
- The role of the National Qualification Framework (NQF), SETAs, Quality Council for Trades and Occupations (QCTO); South African Qualifications Authority (SAQA) and Assessment Quality Partners (AQP);
- Key concepts of education and training like Skills Development Levies, PIVOTAL Programmes, Learnerships, Internships, Skills Programmes and Short Courses;
- Understanding of Recognition of Prior Learning (RPL);
- The Workplace Skills Plan (WSP) and Annual Training Report (ATR);
- The consultation process, establishment and composition of a training committee/ workplace forum;
- The constitution, roles and duties of the training committee/ workplace forum;
- Championing skills development in the workplace

Method of assessment:

Use of formative and summative: Class tests/ assignments/ examination/ case studies/ group projects. After successful completion of the course, participants will receive a Certificate of Competence. **Accreditation** by a relevant SETA on a unit standard set at NQF level 4 or above.

4. Training Methodology and Course Duration

Training delivery will include a combination of both theoretical and practical approaches. The course will be delivered through **classroom sessions** (faceto-face) and may include practical exercises. The duration of the course will not exceed 2 days (class time) combined with practical workplace experience where necessary.

Take note: A successful service provider is expected to provide a conducive training facility that includes catering provisions for coffee/tea, lunch, water, and drinks for the **15** delegates.

An experienced facilitator who has strong subject matter expertise in Skills Development Training. Classroom material, manuals and computer resources for participants. Feedback evaluation, attendance register and progress reports. Training dates will be decided collectively with the successful training provider.


