1. DESCRIPTION OF SERVICES

Area : BELLVILLE OSBORNE
: PAARL K9 DOG UNIT

Services : Once-Off tree felling and pollarding /Pruning
services.
(On request from the department)

2. SCOPE OF SERVICE

BELLVILLE- OSBORNE ROAD.

- 2.1 Pollarding and pruning of the blue gum tree by 50% as will be indicated and marked by the NDPW & Horticulture Project leader.
- 2.2 Apply stump treatment as will indicated by the project leader.
- 2.3 Bush clearing - cutting the grass and invasive alien vegetation to the ground level as will be demarcated by NDPW & Horticulture project leader.
- 2.4 All vegetation cutting waste /dumping materials must be removed from the site immediately.

2.2 PAARL K9 DOG UNIT

- 2.2.1 Tree felling –cut down tree to the grounds level and apply stump treatment as will indicated by the public works officials.
- 2.2.2 Crane equipped with hoist, wire or chain and sheaves will be required for effectiveness of cutting the large tree, due to the obscure and dangerous location over private property apartment block residence.
- 2.2.3 Professional climbers will be required with relevant safety equipment.
- 2.2.4. All vegetation cutting waste must be removed from the site immediately.

3. GENERAL CONDITIONS

- 3.1 The Contractor shall provide all materials, labour and equipment deemed necessary
- 3.2 Staff must be overseen at all times by a supervisor with suitable Horticultural knowledge. Staff may not enter any area which is not clearly work-related.
- 3.3 Service providers should note that service offered must be in strict conformity with the relevant specifications.
- 3.4 Any quotation submitted shall remain valid, irrevocable and open for acceptance by the Department for a period of 30 days from the closing date.

4 OBSERVANCE OF LAWS AND REGULATIONS

4.1.1. Observance of Laws and Regulations

The service provider shall secure all permits and licenses imposed by law and ordinance, pay all charges and fees, and give all notices necessary and incidental to the due and lawful prosecution of the work regarding the obstruction of streets and driveways, maintaining signals and open passageways, and protecting the same where exposed.

4.1.2 Hours of Work:

The service provider shall perform the work during weekdays and within operating hours 08:00 till 16:00 unless requested by a Departmental official to deviate.

4.1.3 Equipment:

The service provider is responsible for providing, maintaining & transporting all necessary equipment in connection with the program of plot clearing described in this Agreement. All other tools and supplies necessary for performing the work required by this Agreement will be provided by the service provider.

4.1.4 Obstruction of Streets and Right-of-Ways:

The service provider will arrange to keep sidewalks open for traffic whenever possible and will block portions of streets only when deemed necessary to protect private property.

Warning signs and barricades shall be furnished and erected by the service provider when warranted.

It is the service provider's responsibility to remove all surplus material and debris from streets as work progresses in order that the public will have adequate use of the affected streets.

- 4.1.4a The service provider shall have in its employ, or under its control, sufficient qualified and competent personnel to perform work promptly and in accordance with a schedule or work program, as approved by the Departmental official.

4.1.4b The service provider shall employ only such workers as are skilled in the tasks to which they are assigned. Workers shall act appropriately and professionally at all times. Offensive language, gestures or actions while in this facility are not acceptable. The Department may require the service provider not to assign any employee the Department deems incompetent, careless, insubordinate, or otherwise objectionable to work on these premises.

4.2 **Safety Standards**

4.2.1a The service provider's employees shall follow all applicable safety standards including operating all equipment in conformance with the manufacturer's operating instructions for each, and in compliance with OSHA standards and requirements.

4.2.1b Precaution shall be exercised at all times for the protection of persons, (including employees) and property. The safety provisions of applicable laws, building and construction codes shall be observed. Machinery, equipment and all hazards shall be guarded or eliminated in accordance with applicable safety provisions.

5. **SITE INSPECTION**

The officials will, at he's discretion, conduct site inspections before, during, and after each service to evaluate the quality, and completion of the work performed.
