**Contract Period:** 6 months period.

**Scope of work.**

- The work in this schedule will only be for treatment of Rodents as listed executed upon instruction by the Department of Public Works and Infrastructure
- In this schedule, treatment will be on the following  
**To include:** Install temper proof station  
Install rodent bait box  
**Products to be used:** Tarnado Blocks  
Muskil Block Bait
- In this schedule, will consist of refilling bait and remove dead rats, this will require 5 visits per request / reference. (Intermediate Replenish of all stations and boxes with Bait and removal of dead rodents at each visit 4 x visits, Final treatment removal of dead rodents and Standard Boxes at fifth treatment /visit.  
**First visit** –install temper proof boxes with bait.  
**Second visit**- Refill bait and remove dead rats  
**Third visit**- Remove dead rats and refill bait.  
**Fourth visit**- Refill bait and remove dead rats  
**Fifth visit** – Remove all the dead rats and refill bait
- **Use of Bait Boxes:**
- All bait boxes shall be maintained in accordance with relevant regulations, with an emphasis on safety. The Contractor shall adhere to the following five points:
  1. All bait boxes shall be placed out of general view, in location where they will not be disturbed by routine operations.
  2. The lids of all bait boxes shall be securely locked and fastened shut.
  3. All bait boxes shall be securely attached or anchored to floor, ground wall, or other immovable surface, so that the box cannot be picked up or moved.
  4. Bait shall always be secured and never in the runway or entry of the box.
  5. All bait boxes shall be labelled on the inside with Contractors business name and address, and date by the service provider technician at the time of installation and servicing.

**General Rules:**

- In this schedule the work will only be carried out only on request per ID/CPT no
- The contractor must also allow in his rates (rodent control) for the removal of dead rats and mice from buildings and roof spaces.
- The (rat/mice) box as described in the schedule rates, must comply to the standards set out by the Local Authority, Health and Safety Act or any other State Act, Act 38/1947 and filled with rodent bait as specified.
- This treatment will be on all Gov. Buildings i.e. DOJ, DOC, Home Affairs, Rural Development, SAPS except Devolved police stations, Defence and other departments.
- Rates will be based on quantities used and quantities will be considered as provisional amount.
- Once the Tamper Proof Stations have been installed they become the property of the Public Works and Infrastructure and cannot be removed.
