



1. INVITATION

The Department of Public Works and Infrastructure, Cape Town Regional Office intends to appoint a service provider for the catering services in Mosselbay with the following address: HR Building, Old Power Station, Munro Street, Santos Beach, Mosselbay

The service will be offered to 15 EPWP Small and Medium Enterprises (SMME's) or Close Corporations from 21-25 November 2022 during their training or capacitation which will take place over the period from 09h00-16h00.

2. CONTRACT PERIOD

The successful and contracted service provider will be issued with a purchasing order which will require him/her to offer good quality catering services for the period of 5 uninterrupted days stated above which are 21-25 November 2022 in HR Building, Old Power Station, Munro Street, Santos Beach, Mosselbay




