

### 1. DESCRIPTION OF SERVICES

<u>Area</u>	: Cape Town
<u>Location</u>	: Parliament Precinct, Genadendal and Highstead
<u>Service</u>	: Supply and delivery of flower arrangement and potted plants/greenery

### 2. SCOPE OF SERVICE

Supply and delivery of fresh flower arrangements.

### 3. GENERAL CONDITIONS

- 3.1 The Contractor shall provide all materials, labour and equipment deemed necessary
- 3.2 Staff must be overseen at all times by a supervisor with suitable horticultural knowledge. Staff may not enter any area which is not clearly work-related.
- 3.3 Service providers should note that service offered must be in strict conformity with the relevant specifications.
- 3.4 Any quotation submitted shall remain valid, binding and open for acceptance by the Department for a period of sixty (60) days from the closing date.
- 3.5 Flowers will be delivered in various areas. Areas will be identified during placing of an order.
- 3.6 The department will order flowers as and when needed.
- 3.7 This will be a three month ending 28 April 2023

### 4. OBSERVANCE OF LAWS AND REGULATIONS

#### 4.1 Observance of Laws and Regulations

- 4.1.1 The service provider shall secure all permits and licenses imposed by law and ordinance, pay all charges and fees, and give all notices necessary and incidental to the due and lawful prosecution of the work regarding the obstruction of streets and driveways, maintaining signals and open passageways, and protecting the same where exposed. Furthermore the

service provider shall be required to vet their workers entering the parliamentary precinct, Genadendal and Highstead premises with the SAPS and the workers should be clearly identified.

4.1.1.1 **Hours of Work:** The service provider shall perform the work during weekdays and within operating hours 08:00 till 16:00 unless requested by a Departmental official to deviate.

4.1.1.2 The service provider shall have in its employ, or under its control, sufficient qualified and competent personnel to perform work promptly and in accordance with a schedule or work program, as approved by the Departmental official.

4.1.1.5 The service provider shall employ only such workers as are skilled in the tasks to which they are assigned. Workers shall act appropriately and professionally at all times. Offensive language, gestures or actions while in this facility are not acceptable. The Department may require the service provider not to assign any employee the Department deems incompetent, careless, insubordinate, or otherwise objectionable to work on these premises.

## 4.2 **Safety Standards**

4.2.1 The service provider's employees shall follow all applicable safety standards including operating all equipment in conformance with the manufacturer's operating instructions for each, and in compliance with OHSa standards and requirements.

4.2.2 Precaution shall be exercised at all times for the protection of persons, (including employees) and property. The safety provisions of applicable laws, building and construction codes shall be observed. Machinery, equipment and all hazards shall be guarded or eliminated in accordance with applicable safety provisions.
