2. PROJECT DELIVERABLES

3.1 Delivery and distribution

Orders must be delivered in full as per the quantity and delivery

NDPWI will return any wrong deliveries at the cost of the service provider.

3.2 Ordering

- Suppliers must be able to receive and respond to a request for quotation through email within 24 hours during working hours (08:00 15:00, Monday Friday, excluding public holidays).
- Purchase orders will be placed with Supplier from time to time as and when goods are required.
- NDPWI reserves the right to place purchase orders until the last day of the contract for deliveries to be effected
 within the delivery period/ lead time specified beyond the expiry date of the contract under the same terms and
 conditions as agreed upon.
- Delivery requirements may be stipulated in purchase orders and scheduled deliveries may be called for.

5. SPECIAL CONDITIONS

It is expected that all deliveries must be accompanied by an original invoice and a delivery note stating the official purchase order number against which the delivery has been effected.
