- 2.1.1 Fell the trees to the ground level and treat all stumps with a suitable herbicides.
- 2.1.2 Caution to be exercised when cut the tree in close proximity to the fence line and any high voltage line.
- 2.1.3 Cut the palms tree to the ground level and apply suitable herbicides.

- 4.1 The Contractor shall provide all materials, labour and equipment deemed necessary. The materials will be in connotation to Horticultural best practices,

such as black bags for refuse removal, herbicides, pesticides, sanitisers, fuel, oils, etc basically consumables items.

- 4.2 Staff must be overseen at all times by a supervisor with suitable Horticultural knowledge  
Staff may not enter any area which is not clearly work-related.
- 4.3 Service providers should note that service offered must be in strict conformity with the relevant specifications.

## 5. OBSERVANCE OF LAWS AND REGULATIONS

### 5.1 Observance of Laws and Regulations

- 5.1.1 The service provider shall secure all permits and licenses imposed by law and ordinance, pay all charges and fees, and give all notices necessary and incidental to the due and lawful prosecution of the work regarding the obstruction of streets and driveways, maintaining signals and open passageways, and protecting the same where exposed.
  - 5.1.1.1 **Hours of Work:** The service provider shall perform the work during weekdays and within operating hours 08:00 till 16:00 unless requested by a Departmental official to deviate.
  - 5.1.1.2 **Equipment:** The service provider is responsible for providing, maintaining & transporting all necessary equipment in connection with the program of plot clearing described in this Agreement. All other tools and supplies necessary for performing the work required by this Agreement will be provided by the service provider.
  - 5.1.1.3 **Obstruction of Streets and Right-of-Ways:** The service provider will arrange to keep sidewalks open for traffic whenever possible and will block portions of streets only when deemed necessary to protect private property. Warning signs and barricades shall be furnished and erected by the service provider when warranted.   - 5.1.1.4 The service provider shall have in its employ, or under its control, sufficient qualified and competent personnel to perform work promptly and in accordance with a schedule or work program, as approved by the Departmental official.
  - 5.1.1.5 The service provider shall employ only such workers as are skilled in the tasks to which they are assigned. Workers shall act appropriately and professionally at all times. - 4 The Tenderer accepts that the Employer may exercise any other remedy it may have in law and in the Contract, including a claim for damages for having to accept a less favourable tender as a result of any such disqualification due to misrepresentation or fraudulent information provided herein;
- 5 Any further documentary proof required by the Employer regarding the information provided herein, will be submitted to the Employer within the time period as may be set by the latter;
