1. DESCRIPTION

- **AREA (1)** : CALITZDORP
- **LOCATIONS** : ERF 355, NO.6 QUEEN (KONINGIN) STREET (LAND EXT. 2673m²)
- **SERVICES** : 1) PLOT MAINTENANCE – 5 X SERVICES.
2) PRUNING / LIFTING OF TREES AND BUSHES – ONCE OF SERVICE.

- **AREA (2)** : OUDTSHOORN NDPWI WORKSHOP (FRONT, SIDE AND BACK AREAS)

2. SCOPE OF SERVICE

2.1 Calitzdorp - Plot maintenance : -

- Mowing of lawn and grass areas
- Cleaning of plant beds and water channels
- Clean/ clear and remove weeds from hard surfaces and apply appropriate Weed killer/ herbicide.
- Pruning / cutting of overhanging branches on fence and roof areas.
- Lifting of trees/ bushes for clear visibility of all building structures on the property.

2.2 Oudtshoorn (NDPW Workshop) - Plot clearing: -

- Mowing and clearing all unwanted grass species and alien growth to ground level.
- Clean and removing of all weeds from hard surfaces and apply appropriate herbicide (weed killer).
- Cutting down 6 Pepper trees and to ground level and apply stamp treatment.

2.3 Site Briefing (none compulsory)

Date and Time briefing: 26 / 04 / 2023 @ 10:30,

Location: Calitzdorp at No. 6 Queen Street, and proceed to the second site in Oudtshoorn NDPW Workshop for a walk through or inspection.

3. INSTRUCTIONS

- Please use every precaution when executing works.
- Treat all hard surfaces with appropriate herbicide
- Remove all cutting waste materials and dead plant debris immediately.

4. GENERAL CONDITIONS

- 4.1 The Contractor shall provide all materials such as black bags for refuse removal, herbicides, sanitisers, fuel, oils etc. basically consumable items, labour and equipment deemed necessary.
- 4.2 Staff must be overseen at all times by a supervisor with suitable Horticultural knowledge.
- 4.3 Staff may not enter any area which is not clearly work-related.
- 4.4 Service providers should note that service offered must be in strict conformity with the relevant specifications.
- 4.5 Any quotation submitted shall remain valid, irrevocable and open for acceptance by the Department for a period of thirty (30) days from the closing date.
- 4.6 NDPWI (Horticulture Unit) reserves the rights to inspect equipment, machinery and premises of services provider who will be appointed.

5. OBSERVANCE OF LAWS AND REGULATIONS

- 5.1 The service provider shall secure all permits and licenses imposed by law and ordinance, pay all charges and fees, and give all notices necessary and incidental to the due and lawful prosecution of the work regarding the obstruction of streets and driveways, maintaining signals and open passageways, and protecting the same where exposed.
- 5.2 **Hours of Work:** The service provider shall perform the work during weekdays and within operating hours 08:00 till 16:00 unless requested by a Departmental official to deviate.
- 5.3 **Equipment:** The service provider is responsible for providing, maintaining & transporting all necessary equipment in connection with the program of plot clearing described in this Agreement. All other tools and supplies necessary for performing the work required by this Agreement will be provided by the service provider.
- 5.4 **Obstruction of Streets and Right-of-Ways:** The service provider will arrange to keep sidewalks open for traffic whenever possible and will block portions of streets only when deemed necessary to protect private property. Warning signs and barricades shall be furnished and erected by the service provider when warranted. It is the service provider's responsibility to remove all surplus material and debris from streets as work progresses in order that the public will have adequate use of the affected streets.
- 5.5 The service provider shall have in its employ, or under its control, sufficient qualified and competent personnel to perform work promptly and in accordance with a schedule or work program, as approved by the Departmental official.
- 5.6 The service provider shall employ only such workers as are skilled in the tasks to which they are assigned. Workers shall act appropriately and professionally

at all times. Offensive language, gestures or actions while in this facility are not acceptable. The Department may require the service provider not to assign any employee the Department deems incompetent, careless, insubordinate, or otherwise objectionable to work on these premises.

6. SAFETY STANDARDS

- 6.1 The service provider's employees shall follow all applicable safety standards including operating all equipment in conformance with the manufacturer's operating instructions for each, and in compliance with OSHA standards and requirements.
- 6.2 Precaution shall be exercised at all times for the protection of persons, (including employees) and property. The safety provisions of applicable laws, building and construction codes shall be observed. Machinery, equipment and all hazards shall be guarded or eliminated in accordance with applicable safety provisions.

7. SITE INSPECTION

IMPORTANT:
