SPECIFICATIONS FOR TREE FELLING & PRUNNING SERVICES AT STATE PROPERTIES

1. DESCRIPTION OF SERVICES

AREAS:

1. Vredendal SAPS
2. Clainwilliam magistrate Court

LOCATIONS:

1. Vredendal SAPS – 38 Tuin street Vredendal
2. Police Residence Vredendal
3. 4 Main Rd Clanwilliam

SERVICES : Tree Felling, Palms Removal Services and Stump treatment

Once Off Service.

2. SCOPE OF SERVICE

2.1 Vredendal SAPS & Police Residence.

- 2.1.1 Fell 1 big Palm and 1 medium size Palm at the police station between the buildings and 1 Palm at the Police residence.
- 2.1.2 Fell 1 dead Tree at the Police residence Vredendal that is affecting the power lines to ground level and treat the stumps with a suitable herbicides.
- 2.1.3 Fell 6 medium size Trees at the Police residence Vredendal to the ground level and apply suitable herbicides for the roots.
- 2.1.4 All vegetation waste /dumping materials must be removed from the site immediately.
- 2.1.5 Caution to be exercised when cut the tree in close proximity to the fence line and any high voltage line

2.2 Clainwilliam Magistrate Court

- 2.2.1 Prune 4 Trees up to 50% in front of the Magistrate Court and seal with suitable sealer
- 2.2.4 Caution to be exercised when cut the tree in close proximity to the fence line and any high voltage line.
- 2.2.5 All vegetation waste /dumping materials must be removed from the site Immediately

3. INSTRUCTIONS

- 3.1 Please use every precaution when executing the tree works.
- 3.2. Treat all cut surfaces with appropriate herbicide.
- 3.3. Remove all waste materials and dead plant debris immediately.

4. GENERAL CONDITIONS

- 4.1 The Contractor shall provide all materials, labour and equipment deemed necessary
- 4.2 Staff must be overseen at all times by a supervisor with suitable Horticultural knowledge
Staff may not enter any area which is not clearly work-related.
- 4.3 Service providers should note that service offered must be in strict conformity with the relevant specifications.
- 4.4 Any quotation submitted shall remain valid, irrevocable and open for acceptance by the Department for a period of thirty (30) days from the closing date.
- 4.5 NDPW & I horticulture reserves the right to inspect equipment, machinery and Premises of services provider who will be appointed.

5. OBSERVANCE OF LAWS AND REGULATIONS

5.1 Observance of Laws and Regulations

- 5.1.1 The service provider shall secure all permits and licenses imposed by law and ordinance, pay all charges and fees, and give all notices necessary and incidental to the due and lawful prosecution of the work regarding the obstruction of streets and driveways, maintaining signals and open passageways, and protecting the same where exposed.
 - 5.1.1.1 **Hours of Work:** The service provider shall perform the work during weekdays and within operating hours 08:00 till 16:00 unless requested by a Departmental official to deviate.
 - 5.1.1.2 **Equipment:** The service provider is responsible for providing, maintaining & transporting all necessary equipment in connection with the program of plot clearing described in this Agreement. All other tools and supplies necessary for performing the work required by this Agreement will be provided by the service provider.
 - 5.1.1.3 **Obstruction of Streets and Right-of-Ways:** The service provider will arrange to keep sidewalks open for traffic whenever possible and will block portions of streets only when deemed necessary to protect private property. Warning signs and barricades shall be furnished and erected by the service provider when warranted. It is the service provider's responsibility to remove all surplus material and debris from streets as work progresses in order that the public will have adequate use of the affected streets.

- 5.1.1.4 The service provider shall have in its employ, or under its control, sufficient qualified and competent personnel to perform work promptly and in accordance with a schedule or work program, as approved by the Departmental official.
- 5.1.1.5 The service provider shall employ only such workers as are skilled in the tasks to which they are assigned. Workers shall act appropriately and professionally at all times. Offensive language, gestures or actions while in this facility are not acceptable. The Department may require the service provider not to assign any employee the Department deems incompetent, careless, insubordinate, or otherwise objectionable to work on these premises.

5.2 SAFETY STANDARDS

- 5.2.1 The service provider's employees shall follow all applicable safety standards including operating all equipment in conformance with the manufacturer's operating instructions for each, and in compliance with OSHA standards and requirements.
- 5.2.2 Precaution shall be exercised at all times for the protection of persons, (including employees) and property.
