1. DESCRIPTION OF SERVICES

- **AREAS** : OUDTSHOORN
- **LOCATIONS** : NDPWI WORKSHOP, VOORTREKKER ROAD (NEXT TO SAPS MOTOR GARAGE).
- **SERVICES** : PLOT MAINTENANCE – 4 X SERVICES
(EACH SERVICE IS ON THE REQUEST OF THE DEPARTMENT).

- **AREAS** : OUDTSSHOORN
- **LOCATION** : SAPS ACADEMY, 1 PARK ROAD SOUTH OUDTSHOORN 6620
- **SERVICES** : Pruning one extra-large tree (Once off Services)

2. SCOPE OF SERVICE

2.1 Plot maintenance : - NDPW & I WORKSHOP OUDTSHOORN

- Cutting of unwanted grass species and foreign vegetation (weeds).
- Cleaning of all sand and stone pits and build surrounding areas including water Channels.
- Cleaning of hard surfaces and apply herbicides (weed killer).
- Pruning / lifting of branches (if any).
- Cutting bushes (if any).

2.2 Pruning services –SAPS ACADEMY OUDTSHOORN

- Prune one extra-large tree and treat all pruned wound with appropriate sealant.
- Cautions is to be exercised when cutting the trees in close proximity to fence line and/or any higher voltage lines.
- All vegetation waste /dumping materials must be removed from the site immediately.

3. INSTRUCTIONS

- Please use every precaution when executing works.
- Treat all hard surfaces with appropriate herbicide
- Remove all cutting waste materials and dead plant debris immediately.

4. GENERAL CONDITIONS

- 4.1 The Contractor shall provide all materials, labour and equipment deemed necessary.
- 4.2 Staff must be overseen at all times by a supervisor with suitable Horticultural knowledge.
- 4.3 Staff may not enter any area which is not clearly work-related.
- 4.4 Service providers should note that service offered must be in strict conformity with the relevant specifications.
- 4.5 Any quotation submitted shall remain valid, irrevocable and open for acceptance by the Department for a period of sixty (60) days from the closing date.
- 4.6 NDPWI (Horticulture Unit) reserves the rights to inspect equipment, machinery and premises of services provider who will be appointed.

5. OBSERVANCE OF LAWS AND REGULATIONS

- 5.1 The service provider shall secure all permits and licenses imposed by law and ordinance, pay all charges and fees, and give all notices necessary and incidental to the due and lawful prosecution of the work regarding the obstruction of streets and driveways, maintaining signals and open passageways, and protecting the same where exposed.
- 5.2 **Hours of Work:** The service provider shall perform the work during weekdays and within operating hours 08:00 till 16:00 unless requested by a Departmental official to deviate.
- 5.3 **Equipment:** The service provider is responsible for providing, maintaining & transporting all necessary equipment in connection with the program of plot clearing described in this Agreement. All other tools and supplies necessary for performing the work required by this Agreement will be provided by the service provider.
- 5.4 **Obstruction of Streets and Right-of-Ways:** The service provider will arrange to keep sidewalks open for traffic whenever possible and will block portions of streets only when deemed necessary to protect private property. Warning signs and barricades shall be furnished and erected by the service provider when warranted. It is the service provider's responsibility to remove all surplus material and debris from streets as work progresses in order that the public will have adequate use of the affected streets.
- 5.5 The service provider shall have in its employ, or under its control, sufficient qualified and competent personnel to perform work promptly and in accordance with a schedule or work program, as approved by the Departmental official.
- 5.6 The service provider shall employ only such workers as are skilled in the tasks to which they are assigned. Workers shall act appropriately and professionally at all times. Offensive language, gestures or actions while in this facility are not acceptable. The Department may require the service provider not to assign any

employee the Department deems incompetent, careless, insubordinate, or otherwise objectionable to work on these premises.

6. SAFETY STANDARDS

- 6.1 The service provider's employees shall follow all applicable safety standards including operating all equipment in conformance with the manufacturer's operating instructions for each, and in compliance with OHSWA standards and requirements.

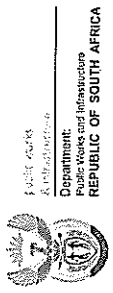
