**TERMS OF REFERENCE (ToR)**  
**TO FACILITATE BID COMMITTEE TRAINING FOR THE DEPARTMENT OF**  
**PUBLIC WORKS & INFRASTRUCTURE – CAPE TOWN REGIONAL OFFICE**

**1. Purpose**

The purpose of the Terms of Reference is to partner with a suitable and accredited training provider to design and deliver a comprehensive 4-day training programme for officials serving on Bid Committees (specification, evaluation and adjudication). The training aims to enhance their understanding of the legislative framework, improve adjudication skills, and ensure compliance, fairness, and efficiency in the procurement process.

**2. Background**

Bid Committees are responsible for the critical evaluation and adjudication of bids in accordance with the Public Finance Management Act (PFMA), Treasury Regulations, and the Preferential Procurement Policy Framework Act (PPPFA). Their role is essential in ensuring that procurement processes are fair, equitable, transparent, competitive, and cost-effective. Given the legal and financial risks associated with procurement, it is imperative that committee members are thoroughly trained in both the theoretical and practical aspects of their duties.

**3. Objectives of the Training**

Course content is based on a unit standard, set at NQF level 5, relevant to Bid Committee training. Upon completion of the training, participants must be able to:

- Understand the legislative and regulatory framework governing public sector procurement.
- Execute their roles and responsibilities as Bid Committee members with confidence and integrity.
- Apply evaluation and adjudication criteria correctly and consistently.
- Identify and mitigate potential risks, including conflicts of interest and procedural irregularities.
- Apply best practices in report writing and documentation for audit trail purposes.

#### 4. Scope of Work and Training Areas to be Covered

The service provider will be required to cover, at a minimum, the following areas:

- **Legislative Framework:** PFMA, PPPFA, Treasury Regulations, and Supply Chain Management (SCM) policies.
- **Roles and Responsibilities:** Understanding the functions of different Bid Committees (e.g., Bid Specification, Evaluation, and Adjudication Committees).
- **The Bid Process:** From advertising to award stage.
- **Evaluation Methodologies:** How to evaluate bids based on functionality, price, and B-BBEE status.
- **Ethics and Governance:** Managing conflicts of interest, declaring gifts, and upholding principles of fairness and transparency.
- **Common Errors and Risk Mitigation:** Identifying and avoiding procedural flaws that lead to disputes, awards being set aside, or audit queries.
- **Case Studies and Practical Exercises:** Based on real-world public sector scenarios.

#### 5. Target Audience

In total, **84 officials**, designated Bid Committee members, SCM practitioners, and internal auditors.

#### 6. Facilitation Methodology

The training must be interactive and blend the following methodologies to ensure knowledge transfer and practical application:

- **Theory:** Facilitator-led presentations on key concepts and legislation.
- **Practical Exercises:** Participants must work through simulated bid stages using real-world documentation.
- **Group Work & Discussions:** Facilitated discussions on case studies and complex scenarios.



- **Q&A Sessions:** Dedicated time for participants to address specific challenges.

## **7. Service Provider Requirements**

The prospective service provider must demonstrate:

- Experience in developing and delivering SCM and Bid Committee training to public sector institutions.
- Accreditation with a relevant SETA or the Quality Council for Trades and Occupations (QCTO) for this type of training.
- A team of facilitators who are subject matter experts with a deep understanding of public sector procurement laws.
- Verifiable references from at least two public sector clients for similar work in the last three years. – 2x purchase orders with corresponding reference letters.

## **8. Logistical Requirements**

The successful service provider will be responsible for providing:

- **Venue:** A suitable, professional training venue in the City of Cape Town, capable of accommodating 84 delegates comfortably for 4 days.
- **Full Catering:** All tea/coffee, refreshments, and lunches for the duration of the training.
- **Learning Material:** Comprehensive training manuals/workbooks for all delegates.
- **Certification:** Printed Certificates of Attendance for all participants who complete the training.

## **9. Evaluation and Reporting**

The service provider must conduct:

- **Post-Learning Evaluation:** A learner questionnaire to assess and measure learner experience.
- **Training Report:** Submission of a detailed report to the Department within 7 working days after the training, outlining attendance, evaluation results, and recommendations.
