**Training Specification: Health & Safety Training Programme: SHE Representative,
Basic First Aid, and Fire Marshal**

1. PURPOSE

The purpose of this training is to equip departmental officials with the necessary theoretical knowledge and practical skills to effectively fulfil the roles of Health and Safety Representatives, Basic First Aiders, and Fire Marshals. The training aims to ensure a legally compliant, safe, and healthy working environment in line with the Occupational Health and Safety (OHS) Act, 85 of 1993.

2. TRAINING OBJECTIVES

Upon successful completion of this training, delegates must be able to:

- **Health & Safety:** Identify workplace hazards, conduct incident investigations, facilitate risk assessments, and understand the legal duties of employers and employees under the OHS Act.
- **First Aid:** Render primary emergency care, manage a medical emergency scene, and apply basic life support techniques until professional medical help arrives.
- **Fire Marshal:** Identify fire hazards, operate basic firefighting equipment (e.g., extinguishers), and execute calm, orderly emergency evacuations as per the workplace emergency plan.

3. TARGET AUDIENCE

Learner Profile: Designated departmental Health and Safety Representatives, newly appointed Fire Marshals, and staff members requiring annual First Aid recertification or initial certification.

Prerequisites: Basic literacy and numeracy; ability to perform physical tasks (e.g., kneeling, lifting, operating fire extinguishers).
