This specification outlines the requirements for a comprehensive computer training program to build foundational and intermediate skills in key Microsoft Office applications, thereby improving workflow efficiency, data management and the quality of internal and external communications.

## **2. LEARNING OUTCOMES**

Upon successful completion of the programme, delegates will be equipped with practical skills to perform their duties more effectively.

## **3. TARGET AUDIENCE**

The course is designed for 15 DPWI officials across all divisions who require enhanced skills in Microsoft Office applications to improve their daily work output. This includes, but is not limited to, administrative staff, secretaries, technical assistants, managers and any official looking to advance their computer proficiency.

## **4. TRAINING MODULES & CONTENT**

The training provider must deliver the following modules, with a detailed curriculum for each:
