## **SPECIFICATION FOR SOURCING A SERVICE PROVIDER: ADVANCED EXCEL TRAINING COURSE**

### **1. Purpose**

The purpose is to appoint an accredited training provider to facilitate an Advanced Excel Training course for Department of Public Works and Infrastructure, Cape Town Regional Office officials.

### **2. Background**

Advanced Excel Training Course is one of the critical aspects of work for any organisation. It offers an opportunity to boost efficiency by providing advanced excel skills to enable employees to automate repetitive tasks through macros and VBA (Visual Basic for Applications) and communicate effectively, significantly reducing the time spent on routine activities. The course is for officials engaged in office administrative or support-related activities Administrators, Secretaries and Supervisors. A total of 32 officials will be attending the training.

### **3. Learning Objectives**

By the end of this training course, participants will be able to:

- Create outlines and subtotals;
- Name, create and modify cell and range names;
- Sort and filter lists and work with tables;
- Use conditional formatting and SmartArt to optimise the display of data;
- Work with PivotTables and Pivot Charts including creating, rearranging and formatting for maximum impact;
- Use advanced list management to validate cell entries and create consistent data tables;
- Produce graphs and tables
- Converting Text to Columns

3.1 The course must be set at a minimum NQF level 4 Unit Standard. On completion of the course, course delegates will receive certificates of completion.

3.2 It is a requirement that all service providers facilitating any training must be accredited with a SETA or Quality Council for Trades and Occupations (QCTO) body and must have a valid letter confirming such accreditation.



#### **4. Training Methodology, Delivery and Duration**

4.1 Training must include a combination of both theoretical and practical approaches. A training provider that will deliver training through a face-to-face classroom in a venue in Cape Town, provide learning material and computer resources with internet connectivity. Use of appropriate case studies and practical exercises. The course duration will be three (03) days of class time for 32 officials.

4.2 It is envisaged that training delegates will be in one (1) classroom, with 32 delegates attending over 3 days. Training dates will be determined collectively with the successful training provider and the course co-ordinator.

3. The total offer on the pricing schedule must be carried over to the PA32 (Invitation to Bid) or the quote will be deemed as non-responsive and will not be evaluated further.
4. No late, incomplete or quotations with correctional fluid will be accepted.
5. Deposit your Quotation into the Quotation box on the Ground floor, customs House Lower Heerengracht, Cape Town.
