- Perform basic first aid procedures in emergencies;
- Identify potential hazards and conduct risk assessments effectively;
- Write well-structured documents that get the message across quickly, clearly and effectively;
- Develop and implement control measures to mitigate risks;

3. Target Audience and Training Duration

3.1 Departmental officials, including managers, supervisors and health and safety committee members. The training will take place over three days, see details:

3.2.1 **Day 1:** Health and Safety (8 hours) for 36 delegates.
